# Crosby man flees Dayton theft

DAYTON – A Crosby man has been charged with multiple crimes after allegedly stealing a camper with someone still in it

The Liberty County Sheriff's Office says James Brown, 75, was jostled from his sleep by someone hooking up his camper July 30. Once on his feet, Brown attempted to turn on a light but his power was disconnected from the County Road 2279 circuit he had been using. Brown then resorted to his cell phone and dialed 911 and conveyed his northbound trek being towed by someone unknown in the direction of Cleveland from near Indian Gully.

Brown while being towed took up his firearm and blasted a few rounds to the north where the truck's cab was. That set in motion a weaving action that knocked Brown's phone from his hand. It is unknown if the weaving was from frieght at being fired upon or to toss the inhabitant of the camper.

By now the Liberty County Sheriff's Office was scrambling to catch the hitched up camper. So, when deputies spotted the truck and camper they chased it about 5 miles. The driver, of course, bailed out of the vehicle and fled into some woods. He had however left items behind inside the truck, one of them was a woman.

The investigaiton is concluded now and Ted Wilson, 43, of Crosby, has been charged with theft and evading. Wilson has a previous conviction, aggravated assault with a deadly weapon. He however remains on the lamb with authorities checking into his old haunts.

The woman found inside the truck, Stephanie Nicole Palmer, 38, is not charged in the incident but she has been remanded to the grand jury to review her involvement.

## Victory on funding of public schools & women's health rights

#### Court decision in favor of **Texas schools**

(Austin, TX) - August 28, 2014 - Judge Dietz ruled in favor of the more than 600 school districts who sued the state over its inadequate and inequitable school finance system. This is the seventh time the state has been sued for improperly funding public

"Today is a victory for the school children of Texas. Judge Dietz simply confirmed what we've all known for years; that the state refuses time and time again to do what's right for our children and the future of our state."

Today's ruling reaffirms that Republican leadership has created an unconstitutional system which values some children more than others, yet short-changes them all."



#### **Senator Garcia praises** decision to uphold women's health rights

(Austin, TX) — August 29, 2014. U.S. District Judge Lee Yeakel struck down a portion of House Bill 2 requiring abortion clinics to become ambulatory surgical centers because the provision places burden on women's access to an important health care op-

tion. The requirement would have gone into effect on September 1, 2014. Other requirements that have gone into effect as a result of House Bill 2 include a twenty week ban on abortions and local hospital admitting privileges for abortion doctors.

"Judge Yeakel's decision is a victory for Texas women in the ongoing battle to protect their constitutional reproductive rights. This onerous and unnecessary requirement is another attempt by the antiwomen's health advocates to erode women's access to reproductive health services, and would effectively force all but a handful of the state's remaining clinics to close. Too many women across Texas are already suffering from the devastating effects of clinic closures due to other ill-conceived requirements in House

## Met an Angel at the Emergency Room

Sunday, August 24 began as a bright, sunny day for me but it all fell apart a couple of hours later. Several people came to my rescue that day and one was an angel that I wish to tell you about in these next few words.

I had just completed a good breakfast at a local restaurant and was standing in line with my guest, Barbara Jones. Suddenly I was sick at my stomach, went to a bench to sit while Barbara stayed in line to pay the bill. Yes, that was the first time I ever used that excuse to have someone else pay a bill.

Next thing I knew I was in the restroom disposing of the good breakfast I had just eaten and some other items in my stomach as well. Then it was into the car and she was driving back to her home, I thought. Not so, she stopped at the firehouse between the restaurant and her home, some EMT's examined me and then it was off to the hospital emergency room. I protested some, to no avail, and then I was on a gurney in the ER.

After the usual check-in, questions, form completions and a few other things, I was taken further back into the ER and put in a bed. There I met an angel, a real Angel as that was her name. Angel was a sweet, lovely, young nurse who would be my caretaker, along with Barbara, for the rest of the day. She was every bit a nurse, knew what she was doing, and was looking after a full-house that morning as every bed in her area was filled—some with patients far worse off than I.

One can hear most everything said between patients, doctors and nurses in this area and we could hear Angel talking

patients. Some she was assisting with problems, cleaning them up, or maybe just discussing what brought them there and how they were felling at present. She always had that cool, friendly sound to her voice as she moved from patient to patient. ## Court rules school finance system unconstitutional

AUSTIN — When the Texas Legislature convenes on Jan. 13, 2015, lawmakers will have the job of revising the state's school finance system,

This task was made necessary on Aug. 28, when state District Judge John Dietz ruled the current finance system violates these four state constitutional standards: the



state property tax prohibition and the education clause requirements of adequacy, suitability, and financial efficiency.

In his 400-page ruling, Dietz pointed out that the Legislature is constitutionally required to "structure, operate and fund" a public school system that achieves a "general diffusion of knowledge" and that "children who live in poor districts and children who live in rich districts must have a substantially equal opportunity to have access to educational funds."

The case was brought in October 2012. Plaintiffs, to whom the court granted relief, are: The Texas Taxpayer & Student Fairness Coalition, et al.; Calhoun County ISD, et al.; Edgewood ISD, et al.; Fort Bend ISD et al.; and Texas Charter School Association, et al.: and Intervenors Jovce Coleman, et al. Defendants are Michael Williams, Commissioner of Education, in his of-

Texas Comptroller of Public Accounts, in her official capacity; and Texas Board of Edu-

Williams reacted, saying, "Regardless of the ruling at the district court level, all sides have known this is an issue that will again be resolved by the Texas Supreme Court."

#### Dismissal order is sought

Gov. Rick Perry's legal team on Aug. 26 submitted a 60page document seeking dismissal of a Travis County grand jury's Aug. 15 two-count indictment of the governor on felony charges of abuse of office and coercion of a public

The document, an application to the 390th Travis County Judicial Court for a pre-trial writ of habeas corpus, contains arguments in support of the governor's veto of the 2014-2015 budget of the state's Public Integrity Unit, a division of the Travis County District Attorney's Office. Perry said he would veto the division's budget unless District Attorney Rosemary Lehmberg, a Democrat, resigned from office after she was arrested for drunken driving in April 2013. Lehmberg refused to resign and Perry carried out the veto, prompting the grand jury indictment.

The conclusion portion of the application for a pre-trial writ of habeus corpus asserts, "continued prosecution of Governor Perry on the current in-

dictment is unprecedented, insupportable, and simply impermissible" and suggests the court "should not hesitate to dismiss both counts of the indictment and bar the prosecution immediately, if not sooner." Also, the conclusion portion states "it is not fault of the court that it has been asked to intrude on a political dispute."

#### Panel to study ethics laws

Texas House Speaker Joe Straus and Lt. Gov. David Dewhurst on Aug. 22 announced appointees to a new Select Interim Committee to Study Ethics Laws, in accordance with Senate Bill 1773 passed by the Legislature in 2013.

The committee will study "the effectiveness of laws and regulations related to ethics, including campaign finance, lobby laws and personal financial disclosure laws," Dewhurst said.

Straus said, "Sound ethics laws can help build and maintain public confidence in government. I trust the members of this committee to give those laws a thorough review and recommend ways to make our system more transparent and accountable to citizens."

Sen. Joan Huffman and Rep. Sarah Davis, both Houston Republicans, will co-chair the committee.

### Lowest-yet interest rate

State Comptroller Susan Combs on Aug. 26 announced the sale of \$5.4 billion in oneyear Texas Tax and Revenue Anticipation Notes, and those notes received a record-low interest rate of 0.1326 percent. The previous low was 0.2008 percent in 2013.

"The best ratings from Wall Street ratings firms and strong demand for Texas notes helped drive down the borrowing cost," Combs explained. Money from TRAN sales is used to help fund expenditures such as public school payments early in the fiscal year and manage cash flow between the start of the fiscal year and the arrival of tax revenues later in the year.

### Extra caution is advised

Texas Department of Public Safety on Aug. 22 reminded drivers to watch out for children walking to and from school or waiting for school

Also, drivers who illegally pass school buses face fines up to \$1,250 for a first offense. A ticket for illegally passing a school bus cannot be dismissed through defensive driving.

DPS Director Steven Mc-Craw said, "Individuals who illegally pass stopped school buses endanger our children, and DPS officers will not tolerate drivers who break the law and put others in harm's way."

## The Swift Fox - Part 3

While family units establish their own territories, they often overlap with other fox family units. Males often change territories while female territories are often established and unchanged centered around a series of

burrows they use as shelter.

Since the canines are small, their burrows aren't all that big. In fact, they often adopt the abandoned burrows of other animals and rely heavily upon them for protection from other predators and from the elements. The dens have a keyhole shaped entrance that's about eight inches in diameter and the dirt is typically spread away from the entrance and not raked in a pile. Their hole extends some six to twelve feet into the ground and during the year, may use multiple burrows within their home range as they move around in search of more prey.

The daytime sighting was especially unusual as swift foxes are primarily nocturnal. They spend their days in their underground dens and emerge at night to hunt for small animals and bugs.

From a dietary standpoint, swift foxes are purely opportunistic - relying on seasonal foods. Summer finds them eating a large amount of insects like grasshoppers. In winter, their diet shifts to rodents, small birds, and carrion.

Biologist W.L. Cutter surveyed the swift fox extensively in the 1950 and documented the variability of their diet. He discovered after examining 12 stomachs and 250 dropping samples that their primary diet consists of cottontails and jackrabbits while other rodents, lizards, and small birds made up the balance. He found no evidence of game birds or poultry in their diet. In all vertebrates made up about eighty percent of the foods found. The remaining twenty percent of their diet consisted of bugs and grass.

From where we found the den of foxes, there is no doubt that they dined on a steady diet of prairie dogs. Their den is smack in the middle of the town. By all accounts the fox are doing well because they look well fed and their coats are sleek. Being a predator, I suspect my squeaking sounded enough like a small rodent that they male couldn't pass up the possibility of an easy meal.

What I can't explain is why he came so close to the truck. Perhaps he'd never seen a vehicle before. After all, people are scarce in this part of Texas and the swift fox are even more rare. Considering their three to five year life span, chances are that he came over as much out of curiosity as he did out of hunger.

While I'll never know the exact reason, I do know that I'm glad he paid me a visit.

## Texans began O'Brien era against Washington: Texas looks to extract revenge against BYU

The Texans begin the Bill O'Brien era on Sunday when they host the Washington Redskins in the season opener for both teams. O'Brien will be the third head coach in the history of the 13-year-old franchise after former head coach Gary Kubiak was dismissed last December after a Thursday night loss at Jacksonville.

Not only do the Texans and Redskins open their seasons on Sunday, but so does the rest of the NFL, which begins things on Thursday night on NBC when defending Super Bowl champion Seattle hosts Green Bay in prime time.

The 2013 season was a disaster for the Texans and their fans. The season began with great optimism and visions of a Super Bowl berth dancing in their heads, but after winning their first two games of the season, the Texans lost 14 straight games and it was time for a new head coach and coaching staff.

Out went Kubiak and in came O'Brien, a disciple of Bill Belichick who came to H-town after serving as the head coach at Penn State for the last two years. O'Brien inherited a difficult situation at PSU with the football program embroiled in the Jerry Sandusky scandal, but his no nonsense approach worked as he produced a 15-9 record with reduced scholarships.

O'Brien and his staff have had an entire off-season, training camp and pre-season to work with their team, but there are still some question marks entering the season. Will Ryan Fitzpatrick be an adequate quarterback? Is Arian Foster fully recovered from an injury-plagued 2013 season and ready to regain the form that made him one of the most productive running backs in the league two years ago? Is Brian Cushing going to be healthy for an entire season (he suffered knee/leg injuries in both the 2012 and 2013 seasons)? And will rookie linebacker Jadeveon Clowney make the impact on defense the Texans are hoping for?

While all of these questions will be answered as the season goes along, there is hope for a rebound season. This is still a pretty talented roster, but the key will be its health. It will also help playing in the AFC, which has two dominant teams in Denver and New England, but is very average everywhere else. Indianapolis is perhaps the third best team in the AFC, but they have issues on both lines and a defense that isn't going to be confused with the '85 Bears.

The Texans schedule is also favorable, especially early. After opening with the Redskins at home, they play at Oakland and at the Giants before returning home to NRG Stadium to take on Buffalo. Week 4 has the Texans playing at Dallas, which had the league's worst defense a year ago. The Texans could realistically win four of their first five, which would have them at 4-1 heading into a nationally televised meeting on CBS on Oct. 9 with Indianapolis at home on Thursday night. Even a 3-2 start would have them in the thick of the AFC South race.

So while last year was a year to forget for Texan fans, should have reason to be optimistic about the 2014 season and the future. It would help to begin things with a win and then move on from there!

The opening of the NFL season takes center stage this weekend, but there is also plenty of action at the high school and collegiate schedules this weekend. So, without further ado, let's take a look at what the weekend has to offer!

### NCAA

BYU at Texas: The Longhorns will have payback on their minds when BYU pays a visit to Austin on Saturday evening. A year ago, UT was run over, around and basically pushed around by the Cougars en route to a 40-21 embarrassment of a loss. That defeat may very well have been the beginning of the end of Mack Brown's tenure in Austin. The team never really recovered from the spanking they received that night and Brown





stepped down at the end of the season and Charlie Strong was hired away from Louisville. Quarterback David Ash also suffered a concussion in that game, so like the rest of his teammates, he has something to prove to the Cougars this time around. ## Environmentalist Jackie Young tells Rotary about San Jacinto waste pits

HIGHLANDS - Jackie Young and her parents lived in Highlands for many years, from 2003 to 2011, until they determined that their health was at risk from toxins in their well water. Their house was previously owned by the Smitherman family, at the north end of Main Street.

As a result, Jackie is now working for TexansTogether,

an activist group headquartered in Austin, dealing with sidering:

public issues such as the environment, education, and voters' rights.

Jackie told her story, and an update on activities around the Waste Pits in the San Jacinto River, to the Highlands Rotary Club at their luncheon on August 19th.

She told how her family, especially her father and herself, became sick with seizures and lesions. Even the pets were sick, she said. The family was forced to quit using well water, and import a fresh supply. When they did that, their health improved.

Her plight was recently told in a full page editorial cartoon by Houston Chronicle artist Nick Anderson, who has championed her story and cause.

Jackie went on to get an environmental geology degree from the University of Houston. Her focus since then has been on the toxic waste pits in the San Jacinto River, and their potential danger to the public's health.

Although the waste pits may not have affected her well water (she says the source is "problematic"), she says the Highlands area has 4 Superfund sites nearby, and there is a high rate of illness in areas such as Highlands, Channelview, and Baytown.

It is known that the waste pits contain dioxin and furans. which can enter the body through breathing, absorption, and eating and drinking. The are known to cause various

types of cancers and other diseases, she said.

Working with TexansTogether and the San Jacinto River Coalition, she wants to have the toxic wastes removed from the site permanently. She said this is one of six solutions now being studied by the federal EPA and the Corps of Engineers. A final decision is due

Other actions EPA is con-

- 1. No Action 2. Control & Moni-
- 3. Cap with upgrade
- 4. Partial solidification in place.
- 5. Partial removal

6. Full removal. This would require 16 months, and cost \$100 to \$635 million to remove 208,000 cubic yards.

Although the Final Report from EPA and

a decision on one of the six actions was to be announced in September of this year, EPA now has referred the matter to the Army Corps of Engineers for further study. This was due to additional concerns about how hurricanes and backwaters from floods would affect the site.

In 2011 EPA required the "responsible parties" to construct a temporary cap, made of a geomembrane covered with stones to be constructed over the site, to contain the wastes. However, it has already been disturbed by storms and needed repairs.

A study made by Professor Sam Brody of Texas A & M identified surge inundation zones that would be covered with waste in a hurricane such as Ike. The study was done for the Galveston Bay Foundation. It hypothesized that during such a storm, dioxins would be carried into homes in Highlands and Channelview.

Young noted that the County has posted signs advising Not to Fish or Eat the Fish in several local waterways near the waste pits. She said that children under 5 are especially vulnerable to the poisons.

She said that the public needs to be involved in the debate, and homeowners near the river should have their wells tested, especially after a storm. If done by a private lab, such as ALS Local, which she has used, the cost is less than \$1000 and may save lives.



girlfriend, Kathrine Gingrich, 26, dead inside their apartment. The boyfriend then went to his aunt's house, nearby, to tell his aunt; both returned to the scene and called

During the investigation deputies found out Johnny Holcomb, 33, who also lives in the neighboring apartment, was a good friend of Ms. Gingrich. When investigators were looking for him, he was not answering the door. Looking through a window, deputies discovered Mr. Holcomb had also been shot.

Holcomb was a good friend of Ms. Gingrich for years, according to Mrs. Vilma Holcomb. And Ms. Gingrich had helped him to get the apartment after separating from his wife about a week ago. Mrs. Holcomb said they were trying to work things out.

The investigation is continuing.
