Mid-term Election results in change of principals involved in Superfund site

term election brought about a number of changes in our elected officials, and some of these are involved in promoting or maintaining progress on the Superfund San Jacinto River Waste Pits.

Three U.S. Congressmen have been involved in getting the site on the Superfund role, and now two of them have been replaced. Gene Green has retired, and his seat was won by Sylvia Garcia. Ted Poe has also retired, and Dan Crenshaw was elected to fill his seat. Brian Babin remains in office. These three Congressmen have repeatedly proded the EPA to put the site on the "Priority List" for remedial action, and to continue to monitor progress

The Superfund site is in Harris County Precinct 2, which will have a new Commissioner in January. Adrian Garcia will hold the position and replace Jack Morman. Morman has been vocal in supporting the clean-up and removal of the toxic wastes at the site, which have the potential to pollute the river and Galveston Bay.

The County Judge is now Ed Emmett, but will be replaced in January by Lina Hidalgo. The county received \$10 million dollars from the lawsuit against the Responsible Parties, and has administered that money along guidelines from the Texas Parks and Wildlife Department. One office-

holder that kept his seat was Briscoe Cain, the state representative for District 127. Cain replaced Wayne Smith, who carried the original legislation through the Texas Legislature to get the \$10 million dollars of the settlement money allocated to Har-

Additionally, this year the EPA replaced their head, Scott Pruitt, with acting head Andrew Wheeler, and several positions at the Dallas EPA Region 6 have changed due to retirements.

ris County.

The EPA has said that the Superfund Process and the Record of Decision, have been set into motion and will be followed to completion. It remains to be seen if the new principals involved are committed to that goal.

HOUSTON - San Jacinto College recently broke ground on two additional buildings that will provide students with state-of-theart learning environments and a central location for student services.

Funded by the College's 2015 bond referendum of \$425 million, the Central, North and South Campuses are undergoing new construction and renovations to existing facilities.

The San Jacinto College Central Campus recently hosted its groundbreaking ceremony for the upcoming Welcome Center building. The new 43,000 square-foot building will serve as a central hub for student services including educational planning, financial aid, enrollment services, business office, testing, orientation and campus tours, veteran services and career services. The building will also have a new computer lab and multi-purspace for workshops, trainings, campus events, orientations and presentations. The College's North and South Campuses currently have Welcome Centers. built in 2011 and 2012 respectively, as part of the College's 2008 bond refer-endum. The Central Campus Welcome Center is expected to open spring

2020.
"This new Welcome Center will be a one-stop-shop for our students to get all of the assistance they need to enroll and stay enrolled at San Jacinto College," said Van Wigginton, San Jacinto College Central Campus provost. "We are focused on removing barriers to student success, and this centralized location for student services is just one of the ways we are ensuring that students have access to all of the essential enrollment and financial services they need in order to succeed in completing their associate degree or technical certifi-

South Campus also had a ground-breaking ceremony to mark the construction of its new 74,000 square-foot Engineering and Technology Center. Expected to open spring 2020, the Center will house the engineering, engineering design graphics, biomedical equipment repair technician and computer information technology programs. The building will also feature computer labs with industry-standard software along with a MakerSpace featuring a 3D print shop, metal shop, and a wood shop to allow students to build their de-

"San Jacinto College is dedicated to providing our students the training and skillsets that our industry partners require for their incoming employees," said Dr Brenda Jones San Jacinto College South Cam-pus provost. "Our industry partners and advisory committees provide our faculty with tremendous insight on the skills and technology advancements that our students need to be proficient in, allowing the College to continue its mission of enriching the quality of the lives in the communities we serve.

According to the Texas Workforce Commission, the need for engineers in all disciplines along the Texas Gulf Coast is expect-ed to increase through 2024, and the demand for qualified engineers in the Houston region remains high. The Greater Houston Partnership says that among metro areas with at least 15,000 engineers, Houston has the fifth highest concentration of engineers in the United States. Overall, the Houston metro area has the third largest number of engineers in the country.

Special Election, to be held on Tuesday, December 11. Early voting will start on Monday, November 26. Four candidates are running for the position, including two well-known state representatives, Ana Hernandez and Carol Alvarado. The other two candidates are Martha Fierro, a Republican, and Mia Mundy. The latter are relatively unknown to voters.

Ana Hernandez now represents District 143 in the Texas House. She is originally from Reynosa, raised in Pasadena, and was formerly an undocumented immigrant that earned her citizenship in

1986. She has been a State Representative since 2005. In the house, she has a record of bill passage rate nearly 50 percent greater than the average She has championed bills that help families find good-paying jobs, crack down on human trafficking, and make neighborhoods safer and more secure. She campaigns for better funding for public schools, immigration reform, expanding healthcare for all, and better roads and infrastructure. She serves on the and Civil Jurisprudence Committee on Licensing & Administrative Proce

dures, and Committee on Redistricting. She has degrees from the University of Houston, and University of Texas. Ana is also a practicing attorney, with her own firm. She has won numerous awards for her work in the Legislature, and in volunteer work.

Carol Alvarado now represents District 145 in the Texas House. She was elected to that position in 2008. Previously she was a member of Houston City Council. She is chairperson of the Texas House Committee on Urban Affairs. She is a member of the Higher Education Committee, and the Select Committee on Opioids and Substance Abuse. She campaigns for protection

for so-called "Dreamers," proper funding for public education, women's reproductive health, and full recovery from Hurricane Harvey. As a legislator she has won numerous awards, including in 2015 the Texas Municipal Legislator of the Year. She holds two degrees from the

University of Houston.

Senate District 6 includes portions of Texas

Plastic Pollution: What to Know

(StatePoint) Plastics are an increasingly widespread pollutant. according to environmen tal experts, harming ecosystems and wildlife as well as endangering human health. One of the largest worldwide industries driving this crisis -- the fast moving consumer goods (FMCG) sector which offers such things as soft drinks, toiletries foods and other consumables -- is not taking significant action to put the brakes on the growing production and marketing of single-use plastics, suggests a new


The report, "A Crisis of Convenience: The corporations behind the plastics pollution pandemic," by Greenpeace, found that single-use packaging is the main delivery system used by all of the companies surveyed and there is no sign of that changing. What's more, none of these companies have comprehensive strategies that include commitments to move away from single-use plastic, with some companies actually increasing the amount of single-use plastic packaging and waste they produce.

"Unfortunately, across the board, the consumer goods industry has failed to take responsibility for the single-use plastics crisis they helped create," said Greenpeace USA ocean plastics campaign director, John Hocevar. "The current commitments corporations have actually allow for increased use in the future. We need more transparency and substantive action immediately.'

Other study findings include the fact that most solutions being explored by businesses are primarily related to addressing recyclability or recycling, not reducing or creating new delivery systems. Unfortunately, most companies know or disclose little about the amount of their packaging that is recycled and even less about the destination of their plastic waste after consumption.

Beyond personal choices, such as recycling single-use plastics and using reusable bags and bottles, Hocevar points out that individuals can make an impact by talking to their local grocery stores, restaurants and businesses about phasing out single-use plastics as well as by writing to some of the larger companies urging them to move in a better direction.

Field of candidates for House speaker narrows to one

AUSTIN — Eight members of the Texas Legislature filed papers with the Texas Ethics Commission to declare themselves candidates for speaker of the Texas House of Representatives, and as of last week, only one remained.

The candidacy of state Rep. Dennis Bonnen, R-Angleton, gained momentum in October, and Bonnen on Nov. 13 announced he had the support of 109 members of the 150-member House. At minimum, it takes 76 votes to elect a speaker, which is 50 percent, plus one, of the 150 members of the House. The other candidates for

the speakership who withdrew from the race include: Travis Clardy, R-Nacogdoches, vice chairman of the House Committee on Local and Consent Calendars; Rep. Drew Darby, R-San Angelo, chairman of the House Energy Resources Committee; Rep. Eric Johnson, D-Dallas, vice chair of the House Redistricting Committee; Rep. Phil King, R-Weatherford, chairman of the House Homeland Security and Public Safety Committee; Tan Parker, R-Flower Mound, chairman of the House Investments and Financial Services Committee; Rep. Walter "Four" Price, R-Amarillo, chairman of the House Public Health Committee; and Rep. John Zerwas, R-Richmond, chairman of the House Appropriations Committee.

Bonnen, 46, first was elected to represent House District 25 in 1997. The district includes Matagorda County and part of Brazoria County. Bonnen currently is chairman of the House Ways & Means Committee and serves as speaker pro tempore of the

The first order of business for the House when the 86th Texas Legislature convenes on Jan. 8 is the election of the speaker, who will succeed Speaker Joe Straus, R-San Antonio. Straus chose not to seek reelection and is finishing a record fifth consecutive

term as speaker.

McCall to lead transition

Bonnen on Nov. 13 announced that he had named former longtime Texas House member Brian McCall, who has been chancellor of the Texas State University System since 2010, to serve as chairman of his transition team. Bonnen said McCall would assist him in recruiting senior staff, planning the swearing-in ceremony and working with outgoing Speaker Straus and his staff to facilitate a smooth transi-

"I've known Rep. Bonnen since his first day as a House member and quickly recognized his leader ship ability," McCall said. "He possesses all of the qualities to be a successful speaker; he is a straight shooter, compassionate, principled and determined to unify the House and work constructively with the Senate and governor.

"Chancellor McCall knows the Capitol and the people who make it work More importantly, he has a reputation as both a legislator and a higher education leader for his fairness, decency and ability to bring people together,"

Bonnen gets thumbs up

Gov. Greg Abbott on Nov. 12 congratulated Bonnen, saying, "no one works harder or more passionately for Texas" than Bonnen. "There are a number of important and pressing issues facing Texas as we head into this next leg islative session, including reforming school finance and elevating our education system and I look forward to working with the new speaker and the entire House of Representatives to address these topics and much more," Abbott added.

Also, in a joint statement released Nov. 14, Bonnen and Lt. Gov. Dan Patrick, who presides over the state Senate, said they had a phone conversation in which they agreed to work together "to move Texas forward" in the upcoming legislative session. "The lieutenant governor and I share a strong commitment to do the people's business," Bonnen said.

DPS expands social media

The Texas Department of Public Safety on Nov. 12 announced the launch of seven regional social media accounts, covering every corner of the state and all seven DPS regions, including North Texas. Southeast Texas, South Texas, West Texas, Northwest Texas, Central Texas and the Capitol Region.

"Each DPS region is unique, and we look forward to using these regional social media accounts to highlight the work of the department in those areas and bolster our ties with communities throughout Texas," DPS Director Steven McCraw said.

TEA releases district ratings

The Texas Education Agency on Nov. 15 re-leased final financial accountability ratings for the 1.200 school districts and charters across the state.

Each school district or open-enrollment charter received one of four possible letter grades — A, B, C or F - and a financial management rating of Superior, Above Standard Achievement, Meets Standard or Substandard

Ninety-nine percent of the districts and charters earned a successful final rating, as measured by the School Financial Integrity Rating System of Texas, a system designed to encourage public schools to better manage financial resources to provide the maximum allocation possible for direct instructional purposes, the TEA said.

Ask Rusty - Will I Get Spousal Benefits?

Dear Rusty: What percentage, if any, should I be able to collect on my husband's Social Security benefits? He started his at full retirement age and I'm turning 62 in 3 months (born 1957). I did work and am eligible to collect on my own work record. Half of his benefit would be approximately \$300 more a month than I would collect with my own benefit. I am not currently working and do not have plans to go back to work. When I called the SS office to make an appointment, I asked this same question and the person I spoke with said I couldn't collect on my spouse. I have a friend who told me his wife did get some extra benefit from his Social Security and she also worked. Signed: Inquiring Mind

Dear Inquiring: Not everyone is automatically entitled to spousal benefits, and everyone doesn't get 50% of the higher earning spouse's benefit amount. Whether or not you are eligible depends upon how much your benefit on your own work record is at your full retirement age, compared to half of your husband's benefit at his full retirement age (FRA). And if you take benefits at age 62, both your own benefit and your spousal benefit will be reduced. Born in 1957, your benefit at age 62 from your own work record will be reduced by 27.5% from what it would be at 66 $_\,(your\ full$ retirement age). Because you're taking the spousal benefit early (you'll be deemed to be filing for spousal benefits when you claim your own) you won't get 50% of your husband's FRA benefit, rather it will be reduced. Here's how you can figure out your total benefit at age 62, and whether you rill get a spousal benefit

First, find out what would be if you wait until your full retirement age to claim (you can get this from Social Security or by creating your own "My Social Security Account" online at www.ssa.gov). Since you say your husband claimed at his FRA, compute one half of his current benefit, and then compare your FRA benefit amount to one half of his benefit amount. If half of his is less than your FRA benefit, you won't get a "spousal boost." If half of his is more than your FRA benefit, you will get a spousal boost, but it will be reduced because you're taking it at age 62 instead of at your FRA. At age 62, rather than half of your husband's benefit you would get about 34% of his benefit, and the difference between that amount and your own reduced age 62 benefit is your spousal boost. That spousal boost, if any, will be added to your age 62 benefit amount to arrive at your total Social Security benefit at age 62 And that total amount will be less than 50% of your husband's benefit. Since Social Security has already told you that you aren't entitled to a spousal benefit, it's probable that your own FRA benefit amount is more than 50% of your husband's FRA amount


