

or both jail time and a fine. Burglary of a habitation in Texas with intent to assault is a second degree felif ony, convicted

punishment by imprisonment in the institutional division for any term of not more than 20 years or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a felony of the second degree may be punished by a fine not to exceed \$10,000.

Harris County Judge Hidalgo urges residents affected by Tropical Storm Imelda to register for FEMA Assistance

Provides Update on Imelda Recovery Effort, Impact on Local Homes and Infrastructure

Harris County Judge Lina Hidalgo on Tuesday urged Harris County residents who suffered damage from Tropical Storm Imelda to register with FEMA for assistance and released additional information regarding the scale of storm damage and ongo-ing recovery efforts.

'I'm pleased that federal officials responded to our requests for additional assistance. Now, it's time for our community to make the most of that assistance. Homeowners and renters who were impacted should contact FEMA today," said Judge Hidalgo. "Our most urgent priority is reaching residents still in need of help, and we'll continue harnessing every available resource to speed their re-

FEMA assistance can provide financial help to those who have necessary expenses and serious needs. The assistance comes in a variety of forms for homeowners, renters, and businesses. To learn more, or register for FEMA assistance, residents can visit the link to the FEMA application

ReadyHarris.org or by calling 1 (800) 621-3362. Registration approximately 20 minutes

to complete.
The arrival of FEMA individual assistance builds upon existing recovery resources already being offered by the county and an array of non-profit groups. These include sup-port for food, debris cleanup, and other social services. An updated listing of those resources are available at ReadyHarris.org or by call-

Judge Hidalgo also provided the following updates regarding the ongoing recovery:
. The Red Cross is now

providing financial assistance to families that have sustained major damage to the pre-disaster living address. Major damage is considered 18" or more of flood water in the home. The Red Cross is providing casework at recovery centers throughout the region. All Red Cross programs do not discriminate on any basis, including religion, geography, origin, or citi-

zenship.
. The Imelda Assistance Fund, established to meet the immediate needs of those who were dis-placed and/or whose homes were damaged by flooding, has secured financial commitments from the community of more than \$400,000.

. According to the most recent estimates, 954 homes and 42 commercial businesses flooded in unincorporated Harris County. In addition, the most re cent estimates from the City of Houston show 1,661 homes and 24 commercial businesses flood-

The Harris County Engineering Department (HCED) has collected more than 12,000 cubic yards of debris left by the roadside by homeowners in flooded areas. To expedite home repairs throughout unin-corporated Harris County, HCED has also been conducting inspections and issuing permits. To date, home inspections are 80 percent complete.

. Several County build-ings experienced flooding, especially those located near Buffalo Bayou downtown. In addition, there were some county parks that experienced damage from Imelda and a few roads that were damaged. HCED estimates total damage of public buildings at \$2.2 million and is working with state and federal agencies to secure FEMA Public Assistance to repair this damage.

GP ISD highlights included Early College High School, with dual credits. There were 13,147 dual credit hours, and 33 Associate Degrees earned. Pre-Kindergarten is available for all 3 and 4 year olds.

Security at each campus includes two trained canines. There are 21 contract deputies, and 2100 security cameras in the schools.

Seniors can gain free entrance to events with a Senior Gold Card. The bus fleet was judge one of the 100 best in the country by a national magazine.

Ms. Johnson spoke about GP ISD being one of the largest employers in East Harris County, with 12 district facilities, 23 schools, and 3,193 employees. In 2019 there were 1,600 graduating seniors. Scholarships for these college-bound students totaled \$8.6 million

CHANNELVIEW ISD

Superintendent Greg Ollis presented the update for the Channelview ISD. \Ol-lis said that the district had $grown \ to \ 10,\!000 \ students \ on$

12 campuses. A \$195 million Bond Issue this year was allowing the district to build replacement school and renovate other campuses.

Ollis said that for security there was an officer on each campus. The district has extensive educational resources, but maintains that "small town" feel.

Innovate programs include AVID prep, innovation grants from the Education Foundation, and a unique Robotics lab.

The district received a "B" rating from the TEA. Ollis says the theme this year is "The Future is in vour hands. SHELDON ISD

Superintendent King Davis said this year's theme is "Level Up." The district had a \$285 bond issue, and is building new schools. It is building a new high school and elementary, and a 10,000 seat stadium. It has 10,000 students on 12 campuses. Growth is 8% per

The district lowered its tax rate by 2ϕ , and gave teachers a \$5000 raise.

A COMPASS program allows students to choose their course of interest: STEM, Performing and Visual Arts, or Technology. In high school, students can get an associate degree.

Flood at Northside Baptist Church

Dear Sir

September 19, 2019 the back of our building was flooded with about one inch of water. The front ditches filled up, backed up, and the water at the back and front of our building had nowhere else to go. Water swept across our property. This has happened before.

The flooding here would be ended with these considerations:

- 1. The ditch on the north side of Barbers Hill Road needs dug out immediately. The culverts need cleaned out. Dirt and debris have piled up both inside and outside the culverts. In a flood these culverts are only about 50% effective.
- 2. There is an abandoned rent house (second house west of Northside) where the drivein is built higher than the other drive ways. This serves to dam up the water once the ditches are full. The other driveways allow the overflow floodwater to flow over them.
- 3. The culverts are too small. The culverts are about 20" to 2411 diame-

ter. Someone from the county mentioned they should be at least 36 inches in diameter. This desperately needs to be corrected.

4. In one spot, the

culvert in front of Northside appears to be caving in. This, of course, would obstruct the water flowing through. Our church parking lot is used not only by our church, but by cars, trucks, school buses through the week. We do not object to this and want to be a good neighbor. Our lot is about the only turnaround on Barbers Hill Road. Tbis adds, however. to the wear and tear, and possibly the culvert caving in. We need new, larger culverts.

We hope the county will immediately begin work on these issues. This letter will be sent to newspapers and anyone who could be of help. Thanks for your time.

Abbott puts Bush in charge of disaster mitigation effort

AUSTIN — A plan is afoot for large-scale, regional projects to improve the state's resilience to hurricanes and other natural disasters, Gov. Greg Abbott announced Oct. 4.

Abbott tapped Texas Land Commissioner George P. Bush to lead the federally funded \$4 billion-plus "comprehensive mitigation" effort. Funding will come from the U.S. Department of Housing and Urban Development under a community development block grant.

"Today we are pushing forward with the single-largest mitigation program our state has ever seen," Abbott said. "Commissioner Bush and I are committed to working together in partnership with HUD (U.S. Department of Housing and Urban Development) and the Texas Division of Emergency Management to maximize the impact of this funding."

HUD on Aug. 23 released mandatory rules for the use of more than \$4.3 billion in congressionally appropriated funding to be administered by the Texas General Land Office. Funding has been earmarked for projects as follows:

— \$4,074,456,000 for Hurricane Harvey;

- \$169,748,000 for 2016 floods; and

-\$52,985,000 for 2015 floods.

The overall total includes certain funds for 2015 floods to be allocated directly by HUD to

— City of Houston,
\$61,884,000; and

— City of San Marcos, \$24,012,000.

Federal disaster declared

The White House on Oct. 4 ordered federal assistance to supplement state and local recovery efforts in Texas counties affected by Tropical Storm Imelda from Sept. 17 to Sep. 23.

The disaster declaration makes federal funding available to affected individuals in the counties of Chambers Harris Jefferson, Liberty, Montgomery and Orange. Assistance may include grants for temporary housing and home repairs, low-cost loans to cover uninsured property losses and other programs to help individuals and business owners recover from the effects of the disaster.

Federal funding is also available on a cost-sharing basis for hazard-mitigation measures statewide. Additional designations may be made at a later date if requested

When Gov. Abbott requested the presidential disaster declaration on Oct. 1, he said, "The recent severe weather in the Gulf Coast region has impacted thousands of Texans, leaving many without the resources they need to recover."

Revenue inches higher Texas Comptroller

Texas Comptroller Glenn Hegar on Oct. 2 announced state sales tax revenue totaled \$2.74 billion in September, an amount 1.2 percent more than the amount reported for the month of September 2018.

"State sales tax revenue grew only modestly in September." Hegar said. "Strong growth in receipts from the construction sector, retail trade and restaurants were largely offset by declining receipts from oil- and gasrelated sectors."

Total sales tax revenue for the three months ending in September 2019 was up 3.2 percent compared to the same period a year ago. Sales tax is the largest source of state funding for the state budget, accounting for 57 percent of all tax collections.

'Farm Fresh' kicks off

Texas Agriculture Commissioner Sid Miller on Oct. 2 announced the start of the Texas Department of Agriculture's annual Farm Fresh Challenge for Texas schools.

The effort encourages schools to buy Texasgrown foods, teach students about the importance of agriculture and celebrate their activities on social media.

More than 220 school districts and charter school organizations have pledged participation for 2019, according to the Texas Department of Agriculture.

DSHS updates case count

The Department of State Health Services on Oct. 1 reported the identification of some 75 Texas cases of severe lung disease in people who report vaping before developing symptoms.

State health officials, who update and post the case count every Tuesday, are gathering more information about 34 other possible cases to determine whether they are consistent with the symptoms and substance use seen in cases in Texas and 47 other states.

Patients range in age from 13 to 75 with a median age of 22 years. About one-third of the Texas cases have been in teens, three-quarters are male and almost all required hospitalization.

Nationally, 1,080 cases have been reported. DSHS is working with the Centers for Disease Control and Prevention, the Food and Drug Administration and other states to gather evidence of what the cases have in common and determine a cause.

I wistfully remember the days I travelled with two pair of shoes (one on my feet) as I tuck another pair into my bag. "So much room!" I think. "Why not bring my black suede boots?" There really is no going back.

But, now that I've adjusted my packing style, Peter and I are surprisingly compatible travelers. We are both slow travelers.

Like me, Peter does not like to dash around from place to place when we are somewhere new. Looking for Resources

On many occasions, I am asked where I find these people or asked if I have a magnet for those in need. I have even had people tell me to quit making myself available to others. No matter how hard I try to not care, it is something that not only inherited from my mother but poured into me by many.

My mother was raised by her immigrant grandparents who leaned on her to help them since they could only speak Hungarian. She had to learn to ask thorough questions so that she did not have to ask too many. Her passion for helping others continued over the decades and she not only served on the parish level of women's organizations at St Andrew Catholic Church, but spilled over to the deanery level, the diocesan level and to the national level. Not only was she the parish representative who helped establish North Channel Assistance Ministries but was instrumental in opening the original Mary's Kitchen as well as being an activist for the homeless long before Tent City was out on old Highway 90.

In addition to her, I had educators who taught me that you go to school to learn how to learn. In the years that followed the influences of people like Walter Lilly, Charles and Velma Chesnutt, Mary Lou Dillard and Janet Long, were the influences of local pastors and ministry leaders.

In 1995, when I found myself going through my second divorce, had it not been for some very resourceful and caring friends, I am not sure if I would

have made it. Later, as my oldest son entered middle school, I came to know and love Mrs Fran Urbanovsky who poured resource after resource into my life. As my second son was diagnosed with a mental illness and both he and my daughter were experiencing things I never thought about, I learned about Cherry Steinwender and the Center for the Healing of Racism. I also remembered that my mother had done volunteer work with Houston Interfaith Ministries which helped along the way As my children faced challenges in their teenage years, I became much like a sponge. I knew I did not have all of the answers but I quickly learned to humble myself and find help.

I had no idea that I would spend the next 22 years working at a community college where students seemed to daily show up needing help. There seemed to be not only students but new faculty that quickly learned to come to my office and I would help. It is no wonder that once I left the college to work for the Constable, that those years of research would come in handy. By the end of each week, I have usually talked to 10 senior adults with needs. This spills over into the lobby of the building where I work as well as into the social media world Rarely is there a week that someone is not reaching out for a

My daily prayer is that when we experience something, we will remember the resources and be able to share with others.
