#### Northshore senior High School student charged with reckless arson



# **Welcome 2020**

Precinct 3 Constable's Office, a Texas law enforcement agency recognized through the International Chiefs of Police-Texas Best Practices Recognition Program, welcomes 2020. Another year is behind us. As we enter 2020, we reflect on this past year and move towards greater accomplishments. In 2019. we moved to create the program CASA (Constable Assisting Senior Adults). CASA caters to our Spanish speaking community and is the counterpart to the R U OK program. Since CASA's creation in July, the program has over 100 participants and R U OK has over 300 participants. These programs cater to the senior citizens in our community. Other community services include almost 6000 contacts made in the Meet the Officer/ Citizen efforts.

Patrol accomplishments include over 11,000 neighborhood and contract checks, as well as 700 vacation watch checks, ensuring proactive patrol of the community. With 204

stolen, 187 stolen vehicles were recovered. Our patrol division operates 24 hours a day, 7 days a week, 356 days a year to protect our communities. They also provide excellent performance in managing calls, traffic incidents and ensuring the safety of others.

Precinct 3 continues to progress with training. In addition to mandatory state requirement, leadership training, continues on a monthly basis in order to ensure the highest quality training for our deputies and supervisors. Additional training includes in excess of over 20,000 hours of police and tactical

The past year brought the creation of a new assessment program for supervisory promotions. The school resources officers participated in active shooter training regularly to ensure the continued protection of our children and the schools they attend.

tion Unit (CIU) exhibits progressive success in seizures and arrests. Through numerous hours of covert surveillance, the unit recovered 78 weapons, 68 pounds of heroin and over 200 pounds of methamphetamine. Recovery of other narcotics include cocaine, heroin, crack and marijuana. Over 150 search and arrest warrants were executed in the quest of keeping members of the community safe.

The Warrants Division took in over eight-hundred thousand dollars, which is a three hundred percent (300%) increase from the previous year.

# Commissioner Adrian Garcia on Gov. Abbott decision to deny refugees

Garcia also plans to participate in Press Conference Tuesday Morning at Catholic

Harris County, TX— Late in the afternoon Friday Texas Governor Greg Abbott announced that Texas would become the first state in the U.S. to reject any additional refugees under President Trump's policy to allow individual states to determine whether to continue to accept them. Using the excuse that, in his opinion, the Federal Government's lack of Immigration Reform is to blame, Abbott is placing D.C. orthodoxy ahead of our shared Texas values -- by arguing that Texas "Texas cannot consent," to refugee resettlement this fiscal year, he sioner Adrian Garcia condemns the decision by the Governor and issues the following statement:

"Harris County has a long and storied history of accepting refugees into our community. Refugees liv-ing here have contributed in countless ways and have helped our county become the diverse, vibrant place in which we love to live and work. This cruel decision by Governor Abbott to make Texas the only state in the union to deny refugees from resettling here is not only disappointing; it does not represent who we are as Texans."

# Social Security Matters

## Ask Rusty – Can My Husband use the "Restricted Application?"

Dear Rusty: My question is about the "restricted application for spousal benefits only" I saw referenced in an February and have applied for my "full retirement benefit" and will continue to work full time. My husband turned 66 this month and has not yet applied for his benefits. According to the Social Security paperwork sent to us, I will receive about \$1900 a month and my husband, who is self-employed, would only receive \$500 to \$600. If my husband claimed "spousal benefits only" using the restricted application, would I still receive my \$1900 and he would receive 50% of that for an estimated total of \$2850? Doesn't seem to make sense to me! As you can see, we must be in denial of our age and are not knowledgeable about Social Security!! Signed: Inquisitive Senior

#### ${\it Dear\ Inquisitive:}$

Based on the amounts you quoted in your email (which I assume were recent estimates from the Social Security Administration), your husband benefits this month and then claim his normal spousal benefit in February when your benefits start. Since your husband has already reached his full retirement age of 66, his spousal benefit will be the full 50% of the benefit you are entitled to when you reach your full retirement age in February

Although your husband qualifies for and can submit a "restricted application for spousal benefits only" (as described in the article you read), there is little reason for him to do so because his own benefit, even if he delays claiming it until he is 70, will be less than his spousal benefit from your record. Instead, since his spousal benefit from you will be the highest amount he will ever be eligible for, he can just claim his own benefit first and then egular benefit to begin when your Social Security retirement benefit starts.

Here's why:

If your husband's current benefit at his full retirement age (FRA) would be \$600 and he's not yet collecting, he could earn delayed retirement credits (DRCs) at a rate of 0.667 per month of delay (8% per year of delay). That will mean his own benefit would be 32% more at age 70 then he is now eligible for at his FRA, which means his maximum benefit on his own earnings record will be \$792/month (\$600 plus

The only reason to file the restricted application (for which he is eligible only because he was born before January 2, 1954) is to let his own benefit grow while he collects a spousal benefit, so he can switch to his own higher benefit later. But since his spousal benefit from you will be about \$950 more than the maximum benefit he can get from his own record at age 70 his most prudent choice would be to simply claim his own benefit now and apply for his normal spousal benefit to start when your SS benefit starts in February. No need for him to file the restricted application because his own benefit will never be higher than his spousal benefit. And just for complete clarity, our husband collecting his spousal benefit from you will not affect your own Social Security retirement benefit in any



# Governor's domestic terrorism task force meets at Capitol

AUSTIN — Gov. Greg Abbott last week convened the quarterly meeting of his Domestic Terrorism Task Force at the state Capitol.

"We must work together to develop meaningful solutions to fully eradicate domestic terrorism in the Lone Star State," Abbott said in explaining the purpose of the meeting. "Just as domestic terrorism takes many forms, this task force is committed to developing comprehensive and evolving defense strategies to ensure a safe and secure future for ev-

ery Texan," Abbott added. Abbott's office said the task force analyzed prevention strategies against domestic terrorism in the form of cyber attacks and discussed the importance of good "cyber hygiene."

Task force members include Abbott, Lt. Gov. Dan Patrick, House Speaker Dennis Bonnen, Texas Attorney General Ken Paxton and other high-ranking state, county and federal officials.

#### DPS releases reports

On Jan. 7, the Texas Department of Public Safety released two reports: the 58-page "Assessing the Mass Attacks Threat to Texas" and the 49-page "Texas Domestic Terrorism Threat Assessment."

In releasing the documents, DPS Director Steven McCraw said it is critical to evaluate public safety vulnerabilities. To further its mission in preventing acts of violence and terrorism, the DPS is urging Texans to report suspicious activity to their local law enforcement or program, a system that captures and connects potential criminal, terroristic or school safety-related threats.

Significantly low rainfall and prolonged dry conditions continue to increase the threat of wildfire and pose an imminent threat to public health, property, and the economy

In the declaration, the governor authorizes the use of all necessary available resources of state government and its political subdivisions.

### Injury statistics

**posted** The Texas Department of Insurance on Jan. 3 referred to U.S. Bureau of Labor Statistics data showing there are more workers in shopping malls and retail outlets that get sick and injured than in any other private industry sector in Texas.

An estimated 33,200 retail workers in Texas suffered a job-related illness or injury in 2018, as compared to 12,300 in construction, 17,700 in transportation and 20,400 in manufacturing, according to the Bureau of Labor Statistics

About 25% of these injuries required Texas retail workers to lose a day

of work, while about 5% of the injuries required employees to lose 31 days or

more of work.

The median time off for injured retail workers in Texas was five days. "There are more retail workers in the state getting injured than employees in construction, transportation or even on factory floors," said Chris D'Amura, director of workplace safety at the Texas Department of Insurance, Division of Workers' Compensation.

"We're seeing a lot of retail workers with sprains, strains, tears and overexertion. According to the U.S. Occupational Safety and Health Administration, the longer workdays, expanded schedules and irregular shifts can negatively affect the mental and physical health of retail workers," D'Amura

said. "When you add less sleep and more crowd stress, it's not surprising we start seeing more accidents. Falls from ladders, slips on floors and trips over boxes and equipment were cited among the most common causes of injuries in the retail industry. Overexertion due to lifting, lowering and repetitive motion is also a high cause of injury in retail," D'Amura added.

#### Paxton reacts to ruling

State Attorney General Paxton on Jan. 6 welcomed the U.S. Court of Appeals for the Fifth Circuit ruling that parties protesting the relocation of Confederate monuments at the University of Texas do not have standing to pursue their law-

suit.

"This case was correctly dismissed months ago for lack of standing, and we are pleased that the Fifth Circuit agreed with our arguments and affirmed the district court's decision," Paxton said. "As the court recognized, the plaintiffs had no legal injury from the university's decision to move property on its campus."

The bronze statues of Jefferson Davis, Robert E. Lee. Albert Sidney Johnston and John Reagan were moved in 2015 and 2017 to the Briscoe Center for American History on the university campus, where the figures are part of an educational display.

The third thing was that I met my best girlfriend, Ange who served as my unpaid life coach and constantly reminded me how important it was to say, "yes," even when "no" was much easier to savperhaps especially then.

The fourth thing that happened was that Angel

Angel died too young and she died only after a colossal fight—because there was still so much she wanted to do. It was then I realized-when I really understood—that the micromanaging style I'd used to plan my life had outrup its usefulness. It was time to let my dreams evolve. It was time to go with the current. It was time to simply say, "yes" to the universe and be prepared for the ride.

# More Texas youth to receive mental health services, remain with families

Health and Human Services Commission and Texas Department of Family and Protective Services are helping more children and youth receive mental health residential treatment services and remain in the custody of their parents or guardians through an increase in availability of residential treatment center beds.

"Supporting families and connecting children with intensive mental health services is at the heart of what this program is about, said Trina Ita, HHSC associate commissioner of Behavioral Health Services. "This additional funding will expand access to mental health care for Texas youth and help keep families togeth-

With an additional \$2.5 million from the 86th Texas Legislature and Governor Greg Abbott, HHSC is increasing the number of beds at residential treatment centers for children and vouth with severe emotional disturbance. The increase brings the number available statewide to 50, up from 40.

"The investments we make in mental health services are critical to ensuring positive outcomes for Texas children," said Sen. Jane Nelson. "As chair of Senate Finance, I am encouraged the Legislature's \$2.5 million investment this session is helping more Texas children access the mental health services they need to lead healthy lives.


A collaboration between HHSC and DFPS, the Children's Mental Health Residential Treatment Center Relinquishment Avoidance Project. helps parents maintain custody of their children in their effort to receive needed treatment services

The project, established in 2013, is a successful alternative to parents legally relinquishing custody of their children to Child Protective Services. It provides care to children and youth with severe emotional disturbance who need intensive residential treatment services without placing them in foster care. This helps keep the child with their family due to the improvement of family relationships and ability of the caregiver to support and care for their child.

Increasing RTC bed availability is a key goal of the agency's strategy to help people access behavioral health services, as outlined in HHS' business plan, Blueprint for a Healthy Texas. HHS anticipates serving an additional 19 children and adolescents in FY 2020. The RTC Relinquishment Avoidance Project served 31 children and youth in FY 2019.

Children and youth receive room and board; intensive mental health services that include group, individual and family therapy; and educational and recreational activities. Meanwhile, parents or guardians receive family case management, family partner services and skills training from their local mental health authority.

"This is a terrific program, and will get these children, from very young to teenagers, the kind of help they need," said Kristene Blackstone, associate commissioner for Child Protective Services at DFPS. "It also eliminates the stress on parents that comes with being involved with CPS and the courts. That worry is no longer there."
