Jacinto City moves May Election

JACINTO CITY-The city council met at their regular time last Thursday evening, and on the Agenda was an item to consider moving the May 2nd Municipal Election to a different date.

Governor Abbott had sent instructions to all municipalities to consider moving their election date to November, due to concerns about people congregating at the polls during the Covid-19 virus pandemic and subsequent lockdown. He strongly advised this action, with possible discipline if it was not followed.

The council voted to move

the election, but did not specify a date, only that it would be in the future. City Manager Lon Squyres said it might be in July, when a run-off election is scheduled

in the county, or November. The council meeting was unusual, because it took place in the new police building, with all participants observing "social distancing" and the public participating by video conference.

Some elections are still scheduled May 2, including the Barbers Hill bond referendum, and Mont Belvieu municipal offices.

Harris County Expands COVID-19 Testing

Mobile Units to Reach All Precincts, Conduct 200 Tests Per Day

HARRIS COUNTY County Judge Lina Hidalgo announced last Monday, April 13, 2020, that two new Harris County Public Health (HCPH) mobile units will provide drive-through testing for COVID-19, adding up to 200 tests per day to the county's current testing capacity. Each pop-up site, which will rotate locations across the precincts starting Tuesday, will be able to make up to 100 drivethrough tests per day. Additionally, testing capacity at HCPH's two existing

stationary sites will increase to 500 tests per location, per day, starting Wednesday.

These two units are in addition to 13 Drive-Thru sites around the county, both public and private

These include 2 Harris County sites, 2 City of Houston sites, 4 free sites by UMMC, and 3 sites by MD Medical.

EMS is 'Front Line' against Covid-19

First Responders are thrust into the front lines of the war on COVID-19, and deserve recognition for their sac-rifice. EMS technicians must answer calls that might include virus victims and therefore they train and prepare for this contingency, as well as their normal emergency calls.

An example is Harris County ESD #5, Crosby's ambulance service, (ESD#5.) They are medical troopers working with local fire departments and law enforcement for the safety of our community.
Asking Medical Chief and Direc-

tor of Operations Christy Graves, CCEMT-P how are treatments and proceedures changing nowadays will get this response, "So, we are having to maintain our normal emergency response work and response to sick and possible COVID-19 positive patients. We have had to stay alert as well as change our protocols often,

the best care for all citizens during this endemic. This includes the PPE we wear to protect everybody because of how close we interview the patients. Obviously, we have to touch people to provide emergency care. We have developed very stringent guidelines to do this including limiting the number of care providers inside the ambulance with patients. We are no longer allowing extra riders including family members to increase safety. The driver of the ambulance is also completely sealed from the rear. This creates a closed ventilation system to help in decontamination of the ambulances."

HIGHLANDS - The San Jacinto River Coalition and its sister organization, THEA held its monthly meeting last Tuesday night by video instead of its usual in-person

planned. Workers on the site have discovered that some of the waste pits are deeper than originally thought. Instead of 12 to 14 feet, some ar-

as deep as 25 feet. Since this means more material must be removed, the EPA indicates the removal process will take longer, perhaps 4 years instead of 2. This will require additional negotiations with the Responsible Parties.
The coalition was also

concerned about a new Corps of Engineers permit, that will allow TxDOT to contract to build new bumpers and supports to protect the IH-10 bridge from accidents that have shut it down twice this year. The permit states that new Dolphin struc-tures, or bumpers, will be built to replace the three in place that are severely damaged, and new fender piling under the bridge for

Constable Diaz responds to lawsuit

Accused of Retaliation The following article vas submitted by Consta-

ble Chris Diaz: On March 12, 2020, Harris County Precinct Two Constable Christopher Diaz moved to dismiss as baseless a federal lawsuit in which the plaintiffs have alleged Constable Diaz violated plaintiff's rights under the First

Constable Diaz's motion to dismiss demonstrates the plaintiffs, several former employees and one current employee, did not engage in any constitutionally protected conduct and. further, there is no connection between any plaintiff's

allegedly protected conduct and a complained of. actionable employment decision. In fact, several plaintiffs have failed to even allege Constable Diaz had any direct involvement in the plaintiffs' reassignment, discipline, or discharge at all.

Precinct Two's records, available to the public under the Public Information Act, further refute each plaintiff's baseless accusations and demonstrate the following:

Jerry Luman: On July 30, 2019, Precinct Two discharged Luman after the Harris County Sheriff's Office and Harris County Constable's Office Precinct

One each independently determined Luman had displayed a lack of commitment and concerning behavior that undermined Constable Diaz's ability to operate Precinct Two. The Precinct One investigator also determined Luman was untruthful during the

course of the investigation. Norman Verbosky: Two discharged Verbosky because of Verbosky had failed to improve his management skills and had failed to attend training with Harris County and the Texas Commission on Law Enforcement. At the recommendation of an independent law enforcement consultant and subject to Verbosky's commitment to improve his management skills, Precinct Two twice offered to reinstate Verbosky's employment. Verbosky declined reemployment and retired from law enforce-

David Williams: Without any notice to Precinct Two, Williams voluntarily resigned his employment on August 28, 2019.

Sara "Cindy" Vara-Leija: Without any notice to Precinct Two, Leija voluntarily resigned her employment on August 2, 2019.

Marcus Anderson: On November 11, 2018, Anderson provided to Precinct Two a medical clearance in which a medical doctor indicated Anderson was "fit for duty." Precinct Two subsequently reassigned Anderson's shift. Anderson voluntarily

Dwayne Pacifico: At the recommendation of an independent law enforcement consultant, Precinct Two re-assigned Pacifico's shift.

On March 5, 2020, the Friendswood Police Department arrested Pacifico and charged him with felony injury to a child. Pacifico subsequently admitted to the Friendswood Police Department that he assaulted and injured the child, who is Pacifico's family member. As a result of Pacifico's admitted commission of a felony, as well as the findings of the Friendswood Police Department and Precinct Two's Internal Affairs Division, Constable Diaz discharged Pacifico effective March 12, 2020.

Ricardo "Pico" Rodriguez: Rodriguez voluntarily resigned his employment on June 9,

Javier Zavala: Zavala voluntarily resigned his employment on August 15, 2019.

Mary Ann Carrion Without any notice to Precinct Two, Carrion voluntarily resigned her employment on June 3, 2019.

Delayed Dreams (Part 2)

I have been blessed to meet many interesting people in my lifetime. In December of 2018, while attending the funeral of a friend, I was sitting next to a mutual friend who began to talk about how interesting the funeral guests were. She noted that Pastor Steven had lived a very interesting life, filled with many eclectic friends. As we looked around the church, we saw professionals, engineers. geophysicists, teachers, nurses, politicians, member of the homeless community and several hundred attendees who were from all ages, races and economic statuses

Suddenly she laughed and stated that my group of friends and contacts were about as eclectic as Pastor Steven's friends. Then she asked if I had been raised in a diverse community. I laughed. I explained that until sixth grade, I had not had an African American classmate. My parents were very different from each other and that was probably about as much diversity as I had been around. My dad was the youngest of six children from a small east Texas town. My mom was the oldest of eight children raised in Chicago. My friend asked me how in the world did I turned out the way I did. She talked about how much of an extrovert I was and how I seemed to love everyone. She was aware that I had been married twice, once to a Caucasian and once to a Black man. She had seen me interact with the homeless as

I laughed and told her that it really started with my first job. I explained that I worked for a credit union that was located inside of one of the company's building. I started telling her that I was a teller and that one of the most interesting people I had ever met, who probably started me on my journey to meeting great people was one of the men from them. She asked me what company and when I said Shell Oil, she told me that she had worked at Shell Oil in the early 1980's and asked which location and did I remember the man's name. I gave her the name and address of the office building as well as his name. Suddenly a smile appeared on her face that was priceless. 'I just talked to him two days ago. Let me give you his phone number.'

The funeral started and I kept thinking I should get up and walk to the lobby and call my friend. Suddenly, as Pastor Steven's granddaughter starting to share memories about her amazing grandfather, the young man she was dating fell and he was out cold. People were screaming as our Pastor stood up and began to lead us all in prayer. Steven's daughter in law was calling 911. Just as the paramedics arrived and began to rip off John's coat, tie, shirt shoes and started CPR they covered him with

Harris County Clerk urges voters 65 and older to vote by mail as precaution to COVID-19

Early voting for the Primary Runoff Elections is July 6-10

Houston, Texas — Harris County Clerk Diane Trautman urges voters 65 and older to vote by mail to ensure their safety during COVID-19 outbreak. Last month, the governor postponed the May 26 Primary Runoff Elections and rescheduled them for July 14, with early voting taking place July 6-10. The deadline to apply to vote by mail ballot for these elections is July 2.

"Our office will do everything it can to ensure a safe, secure, and accessible election," said Trautman. "In order to do anything different from a normal uniform election, our will require explicit guidance from the Texas Secretary of State."

To be eligible to vote by mail in Texas, a voter has to be 65 years or older, have a disability or illness, be out of the county during the election period, or be confined in jail, with no conviction. Voters can go to www.harrisvotes.com to print out the application or call 713-755-6965 to request one. The last day to register to vote for the July 14 election is June 15. For voter registration informa-

tion, please contact the Harris County Tax Office.

"The procedure for mail ballot applications has always been to honor any request from a voter who checks the disabled box. We are not going to question someone's disability," added Trautman. "Any ability to expand the Ballot-By-Mail program will need to be granted at the state level."

Harris County Attorney ready to take on price gouging

Harris County Attorney Vince Ryan has set up a website for residents to file complaints about price gouging.

During a disaster, the Texas Deceptive Trade Practices Act makes it illegal for a company to sell or lease fuel, food, medicine, lodging, building materials, construction tools, or another necessity at an exorbitant or excessive price.

"Unfortunately, there seem to always be people who will take advantage of a crisis situation," said County Attorney Ryan. "Our office wants you to reach out to us to let us know about a price goug-

ing situation.'

The County Attorney's website explains the details you need to provide to file a complaint. It explains the process the Office will use to investigate a complaint and how it will be dealt with if it is determined that price gouging occurred.

Since the COVID-19 emergency declaration was issued, the County Attorney's Office has received 115 price gouging complaints. Thirty-five have been investigated. Each case is looked at individually. Investigators will contact a store and determine how much a store paid for

an item and how much they are marking it up. Some products are more expensive for a store to purchase now; higher prices are not necessarily price gouging. Five cease and desist letters have been issued so far. If a company refuses to comply with the letter, a lawsuit may be filed.

COVID-19 BUSINESS ASSISTANCE Paycheck Protection Program

The Paycheck Protection Program is a loan designed to provide a direct incentive for small businesses to keep their workers on the payroll.

SBA will forgive loans if all employees are kept on the payroll for eight weeks and the money is used for payroll, rent, mortgage interest, or utilities.

You can apply through any existing SBA 7(a) lender or through any federally insured depository institution, federally insured credit union, and Farm Credit System institution that is participating. Other regulated lenders will be available to make these loans once they are approved and enrolled

in the program. You should consult with your local lender as to whether it is participating in the program.

Lenders may begin processing loan applications as soon as April 3, 2020. The Paycheck Protection Program will be available through June 30, 2020.

o Any small business concern that meets SBA's size standards (either the industry based sized standard or the alternative size standard)

o Any business, 501(c)(3) non-profit organi-

zation, 501(c)(19) veterans organization, or Tribal business concern (sec. 31(b)(2)(C) of the Small Business Act) with the greater of:

o 500 employees, or o That meets the SBA industry size standard if more than 500

o Any business with a NAICS Code that begins with 72 (Accommodations and Food Services) that has more than one physical location and employs

less than 500 per location o Sole proprietors, independent contractors, and self-employed persons




