# Allatia Harris new Chamber Chair

Dr. Allatia Harris was sworn in as Board chairman for the North Channel Area Chamber of Commerce on Tuesday, January 19th, 2021, virtually via Zoom at the first Chamber Board meeting of the year. Harris County Justice of the Peace Lucia Bates performed the ceremony, and additional officers and directors took the oath that morning to "promote business growth and quality of life in the North Channel Area? Raised in Dallas, Harris

attended the University of North Texas, where she majored in Communications, obtaining her Bachelor's and Master's Degree. Dr. Harris holds a doctorate in educational administration with a specialization in community college leadership from the University of Texas at Austin where she has been recognized as a Distin-

guished Graduate. After being in administration in the Dallas county community colleges, a presidency opened up at the San Jacinto Community College North Campus. Not wanting to leave Dallas, Harris was hesitant to interview; when she went to the campus, she fell in love with the North Channel community.

Serving as President of San Jacinto College North for five and a half years, the college changed how it operated. Her position evolved into what she works as today, Vice Chancellor of Strategic Initiatives - Workforce, Community and Di-

versity. She started working with the workforce programs, organizations, businesses in the communities, as well as diversity initiatives. As an advocate of education, Harris went on to elaborate on the opportunities community college offers. She says, "this is something I wish people understood, particularly in low-income communities, if you want to work in healthcare and need to work now, you can get a short-term credential, but that doesn't mean you have to stop there." Nationally, Dr. Harris is past president of the American Association for Women in Community Colleges.

When discussing what attracted Harris to the North Channel area, she was honest in saying, "It was a job expectation, but the first year one of the Rotarians got me involved in a project, we were working with another group and funded a home for a disabled veteran who had returned" She goes on "When I started doing the service work, I got hooked."

She explained the chamber "is a voice about road improvements that we need, is the voice for the infrastructure that the communities and businesses need." As new Chairman Harris says, her goal first and foremost is "to get through COVID, it has made a lot of things challenging. We want to keep our businesses connect-

The chamber "works with governmental entities, Congresswoman Sylvia Garcia, the mayors of Jacinto City, and Galena Park, and Pct. 2 Commissioner Adrian Garcia to get the word out about vaccinations, food, and water giveaways and resources. We build networks and help keep people connect-

Allatia Harris reports that she is excited to be the new chairman. "When I am with the board even over Zoom, I feel so hopeful and optimistic for the community." She appreciates the group's diverse and welcoming people that are so committed to the community she now helps serve.

# Channelview concerned about dredging for more barges near Superfund Waste Pits

cording to the C.H.I.C. community action group. residents in the San Jacinto River Estates area along the San Jacinto River near the Waste Pits received a notice letter last week from the Corps of Engineers, calling attention to a dredging and mooring project in the river near Meadowbrook Park and asking for comments within 15 days.

This is apparently a continuation of a project that was attempted last year, by the landowners TimTom Holdings and Holtmar Land LLC. In that project, excavated materials from the south side of I-10 were to be hauled to Beach City, and deposited in a landfill site near a park and residen-

citizens and the city government managed to stop that work.

Carolyn Stone of C.H.I.C. says she believes that this project is using an old permit, with a different description of the work. She believes they would need a new permit for this, which is a different project.

According to the Corps. the applicant proposes to mechanically dredge approximately 15,000 cubic yards (405,000 cubic feat) of material from a 2.50-acre area of the San Jacinto River. The dredged material would be placed in a scow barge, transported and off loaded into watertight haul trucks for final disposition on a 5.O acre upland

tract lined with a geosynthetic clay liner.

The final dredge material placement area is located approximately 35 miles northeast of the project site in the city of Devers.

The project also involves the installation of 576.75 linear feet of bulkhead to stabilize the shoreline in two separate areas and three 36-inch steel monopile moorings within the San Jacinto River and two on land. Barges would be secured to these moorings.

C.H.I.C. has asked for broad support to oppose this project, which may endanger the Waste Pits, and awaits more information from the Corps of En-





We are emerging from the thaw with so much work to do, however, now that spring is on the horizon, it's finally the time of year that our area parks can be a welcome place for ANYONE to get some rest and relaxation. Under my direction, all Precinct 2 Parks will be welcoming to all visitors.

The crown jewel of these efforts will be James Driver Park in Aldine. As the first county-owned all-inclusive, fully accessible park, James Driver Park will offer something for everyone. The playgrounds will feature specially designed, wheelchair-friendly equipment where ALL kids can spin, sway swing, slide, and splash. It will have a misting area and plenty of shade for relief from our hot summer days, plus covered dining spaces. There will also be a sensory garden featuring indigenous perennials, an accessible event lawn for music and other entertainment, a designated area for taco and other food trucks, and so much more. We are so excited to debut the brand-new James Driver Park this summer.



James Driver Park isn't the only Precinct 2 park that is becoming more accessible. Going forward, most trails in our parks will be expanded to be six to eight feet wide to accommodate wheelchairs. We are upgrading playgrounds to offer more accessible activities such as an ADAcompliant zip line (Bay Area Park in Clear Lake). We've added more splash pads, inclusive swing sets (Burnet Park in the Lynchburg-area), roller slides (Stratford Park in Highlands), and ADAaccessible workout equipment (Highlands Park in Highlands, Crowley Park in East Aldine, and Riley Chambers Park in Barrett).

As long as I am your Precinct 2 Commissioner, my team will always work to ensure that residents of our community will have many options to take a break from the grind of our daily lives. And after the last few weeks, months, and year we've just had, these changes to our parks couldn't come at a better time.

# STATE CAPITAL HIGHLIGHTS **By Gary Borders**

### State's jobless rate still double the record low rate

The state's unemployment rate dropped to 6.8% in January, down a tick from December's 6.9% rate but double the record low of 3.4% in May 2019. It is unclear what effect the mid-February winter storm had on employment, when power outages swept the state and many roads were impassable. We'll find out next month.

What is certain is that state lawmakers must grapple with a revenue shortfall as they build a biennial budget, since sales tax revenues are down from the previous year. The state comptrol-ler's office announced February sales tax revenues totaled \$2.68 billion, down 7.5% from the same period last year.

Sales taxes account for most of the state's revenues. Texas Comptroller Glenn Hegar announced in January that the state was running a \$1 billion defi-cit for the current budget. Hegar estimated state budget writers will have an estimated \$112.5 billion in revenue available for the next two-year budget, which is nearly \$500 million less than the total current budget. Hegar said the forecast

could change due to uncertainties such as the continuing effect of the pandemic, oil and gas revenues and how quickly the state's economy rebounds as the state fully reopens.

## ABBOTT, PATRICK SPAR OVER PUC, ERCOT

The market monitor for the Public Utility Commission has revised its claim that the Electric Reliabili-Council of Texas overcharged power companies by \$16 billion during the winter storm, saying last week that the actual amount is \$4.2 billion.

Gov. Gregg Abbott has made legislation relating to correcting any ERCOT cy item. In a highly unusumove, Lt. Gov. Dan Patrick showed up at a state senate committee hearing to question the lone remaining member of



the PUC — new chair Arthur D'Andrea. Patrick on Friday night called on Abbott to replace D'Andrea after he fills the other two vacancies on the PUC. Patrick also said Abbott should intercede to "correct" the pricing error.

Abbott quickly — and tersely — responded to Patrick, saying that, as a former Supreme Court justice and former Attorney General, the governor's le gal view is that he does not have "independent authority to accomplish the goals you seek," which is why he made the issue an emergency item for the Legislature to consider. This saga is far from over

### PARTS OF TEXAS STILL **FACE DROUGHT**

Despite record snowfalls in much of the state, precipitation in February was below average, which led to an increase in the area of the state affected by drought. Dr. Mark Wentzel, a hydrologist with the Texas Water Development Board, said rain during April, May and June will be crucial. The expected breakup of the La Niña weather system in April could bring a return to normal amounts of rainfall in May and June, Wentzel wrote.

He noted that there will be pockets of drought almost always in such a vast state. Right now, the Unit-ed States Drought Monitor state is in some stage of drought, with the most severe areas located in parts of the Panhandle and the

Rio Grande Valley. Only 10.8 percent of the state's area has normal rainfall conditions, primarily in Northeast Texas.

# COVID-19 VACCINES STEADILY RISING ACROSS

With another 800,000 doses of COVID-19 vaccines arriving in Texas this week, more than 5.2 million people have received at least one dose, and 2.78 million are fully vaccinated — about 9.5% of the state's population. The latest shipment is down from the 1 million first doses delivered last week which included the first large batch of the one-shot Johnson & Johnson vac-

Last week the Texas Department of State Health Services an-nounced that vaccinations have been expanded to people over 50 years of age. Previously, school and child-care workers were added to the Phase 1B list, which also included people over 65 and those with un derlying medical condi-

"We've seen a remarkable decrease in the number of hospitalizations and deaths since people 65 and older started becoming fully vaccinated in Januar said Imelda Garcia, DSHS associate commissioner. "Expanding to ages 50 to 64 will continue the state's priorities of protecting those at the greatest risk of severe outcomes and preserving the state's health care system."

### COVID-19 CASES, DEATHS **CONTINUE TO DROP**

The number of new cases of COVID-19 in Texas dropped again last week to 31,916 — down 26% from the previous week. A total of 1,117 deaths were reported, down 35% from the previous week. To date, there have been 2.7 million cases in the state since the pandemic began, with 46,366 deaths, according to the Coronavirus Resource Center at Johns Hopkins University.

Hospitalizations of confirmed COVID-19 patients also continue to decrease. with 4,219 patients currently in Texas hospitals, according to TDSHS. That's down 14% from the previous week and 70% lower than the record high of 14,218 hospitalizations in mid-January.

### TEXAS YOUNG LAWYERS **LAUNCH WEBSITE** HONORING ICONIC WOMEN IN LEGAL HISTORY

The Texas Young Law-yers Association this week launched an online site intended to educate students about women in our nation's legal history who have fought for equality and civil rights, and who have helped shape American culture. The project is designed to give Texas high school teachers an effective tool to teach students about such iconic women as Rosa Parks and Susan B. Anthony. 




