# City, County join in Gun BuyBack program

HOUSTON - As part of his One Safe Houston initiative, Mayor Sylvester Turner is holding a Gun Buyback program to reduce the number of guns on our streets. The City -County Partnership will reduce the number of Unwanted Guns on our streets.

To make Houston's homes and streets safer and free from violence, Harris County Commissioner Rodney Ellis, Houston Mayor Sylvester Turner's Office and Police Chief Troy Finner announce a gun buyback program that will take place July 30. With no questions asked, residents can turn in firearms in exchange for gift cards in the amount of \$50, \$100, \$150 and \$200 – depending on the type of gun. It's part of a coordinated effort to reduce violent crimes.

The event, in partnership with Harris County



Precinct One Commissioner Rodney Ellis, the Houston Police Department, and Wheeler Avenue Baptist Church, will take place from 8 a.m. - noon on Saturday, July 30, at 3826

Wheeler Ave. Gift Cards will be available as follows:

\$50 Gift Card for nonfunctioning firearm

\$100 Gift Card for rifles or shotguns

\$150 Gift Card for hand-

\$200 Gift Card for an

automatic rifle

The no-questions-asked Gun Buyback program is open to all members of the public. People should unload the firearm before arriving at the collection site

and place it in the trunk or the rear of their vehicle. HPD personnel will remove the gun from the vehicle and ensure the firearm is unloaded and rendered safe. Once the weapon is collected, the person donating will receive a receipt to exchange for a gift card.

One Safe Houston is a \$53 million investment aimed at crime reduction. The comprehensive violence reduction initiatives link research-based strategies to improve public safety and reduce the harms caused by violent crime.

The initiative focuses on four (4) key areas:

--Violence Reduction

and Crime Prevention --Crisis Intervention,

Response and Recovery --Youth Outreach Op-

portunities -- Key Community Partnerships

Mayor Turner, Commis-

sioner Ellis, and event partners will announce additional Gun Buyback program details on Monday, July 18.

"We can't solve the gunviolence epidemic overnight, but we can take action right-now by removing guns from the streets." Commissioner Ellis said. "Gun buyback programs create an incentive for residents to turn in their firearms. I would argue there are two incentives: one is a gift card, the other is creating a safer community."

Said Mayor Turner: "The Gun Buyback program is part of my One Safe Houston initiative. Our goal is to get unwanted guns off the streets to prevent their use in a crime or an accidental shooting. I thank Commissioner Ellis, Wheeler Avenue Baptist Church, and

#### **Griner trial in** Russia update

Houston native and Nimitz High School graduate Brittney Griner, a WNBA star basketball player, remains in a Russian jail after her third day of trial last Thursday. She has pleaded gulty to a minor drug charge, and the third day of her trial consisted of character witnesses. US officials were present at the proceedings.

She has been able to communicate with her family, wife, and President Biden through written out emails and letters.

Her next day in court is July 26th. Experts say her conviction is almost certain, with imprisonment for up to 10 years, unless the US is able to bargain for her

# Galena Park ISD trains for School Safety

#### Preparation to deal with an **Active Shooter**

GALENA PARK - In the aftermath of the terrible murders at a school in Uvalde, parents and students have been concerned about safety and security as they prepare to return to schools in August.

In the Galena Park school district, school safety is a top priority, with the district police department trained and equiped to handle emergencies such as active shooters.

In an interview with this newspaper, GPISD police chief Bryan Clements outlined the safety measures enacted through all the schools. In addition, the yearly simulation drill was broadcast live on local television station KPRC

channel 2, with an interview with Cathy Hernandez, a Galena Park graduate.

Clements said that for a number of years, armed officers have been assigned to each middle and high school, and that this year the GPISD trustees have increased the number of police officers from 21 to

40, with the hiring of an additional 19 positions. This number provides an officer for each school, from K through high school.

Clements said that all the officers are put through rigorous training, and once a year have an 8hour class session and drill regarding how to suppress an active shooter.

Safety and security routines are also part of each schools daily routine, Clements said. Officers and school staff are instructed that all outside doors must be locked, and classroom doors also locked during class. Officers are instructed to check each door throughout the day for compliance.

Schools are also equiped for this type of active shooter emergency, with a ballistic shield and medical equipment stocked and available at every school.

The Safety Drill was available to see on television, Clements said, because it is important for families to see that students will be protected when they come to school.

As part of the active shooter training, officers

# JC Arrest leads to discovery of Catalytic Converter thief

Jacinto City - May, 2022 Jacinto City Police Sgt. J. Aguilera while on routine traffic control stopped a speeding violator driving a Lexus SUV. Officer Aguilera discovered the Lexus driver Mack Arthur Kizzee (see photo) did not have a driver's license and he also smelled the odor of marijuana coming from

During a standard vehicle probable cause search for marijuana Sgt. Aguilera discovered a catalytic converter which appeared to be sawed off from some unknown vehicle and a blue colored portable saw with a metal saw blade attached (see photo).

As Sgt. Aguilera was attempting to place suspect Kizzee under arrest for the traffic violations he resisted and fought free thus preventing from being handcuffed. He began running away from Sgt. Aguilera and Officer C. Calvillo who had arrived there moments earlier to assist with the arrest.

#### How Do You Do It?

The one question that I am asked most often, is "How do you do it?" Life is not easy, and I doubt if there are many readers who do not feel the same way. Life has changed for all of us. Some people have experienced more changes than others. There are unique obstacles that we face. There are some obstacles which may have similarities yet, no two people experience the same life.

I find myself speaking to hundreds of people weekly on the phone. On social media, I communicate with even more. Working for a government organization now, as well as having worked for a community college for 22 years, living in the same community for 50 years and being involved with many non-profits and other organizations, I am blessed to know many people.

Within the last week, I have learned of deaths of former church members as well as three of the senior citizens that were active in the program I work with. On Tuesday evening, I drove my daughter in love to see her mother in the hospital. We had no idea that this would be the last time we would see her smile, ask about the grandbabies and fuss about being in the hospital instead of being at home with loved ones. Less than five hours later, my son called asking if I could drive his wife to the hospital as the nurse had called that his mother-in-law was in distress.

Even though I drove above the speed limit, while praying there were no deputies on the toll road, we made it a few minutes too late. Once again, I found myself calling on God to provide peace, comfort, and the right words to share. The next few hours were filled with phone calls, text messages and prayers. Before I had time to process what was ahead, I had a friend call me concerning her 62-year-old mentally ill brother who had been missing for weeks. She was struggling with how to know what to do next. Another friend reached out asking how to find help for her son who lives with Autism.

As the week rolled on, a senior citizen called to ask what to do about her son who just came up for parole and was moved to a prison unit where there are many known gang members. He had called his mother as he was afraid that the current situation. She was not sure if she should contact the Warden or the Chaplain. We prayed and she contacted the Chaplain. A young lady in our community who was just sentenced to five years in prison is having a tough time adjusting to her surroundings. Her mother and uncle are unable to visit her due to circumstances. Her mother was asking if I could send her an encouraging letter. As I hung up the phone, I realized that her mother needs one as well.

By the time Sunday arrived, I was so thankful for God's grace and mercy. When my friend with cancer called and was asking about another friend who lives with CTE due to many concussions received while playing professional football, he asked that question again, "Charlie, how do you do it?" And I reminded him that with God all things are possible.

# Diamond Jim: "What is the birthstone for July?"

JULY'S BIRTHSTONE IS RUBY



There's no better way to demonstrate your love than by giving a ruby in celebration of a July birthday. Rubies arouse the senses, stir the imagination, and are said to guarantee health, wisdom, wealth and success in love. Fine-quality ruby is extremely rare, and the color of the gem is most important to its value. The most prized color is a medium or medium-dark vivid red or slightly purplish red. If the gem is too light or has too much purple or orange, it will be called a fancy-color sapphire.

A ruby is a pink to blood-red colored gemstone, a variety of the mineral corundum (aluminum oxide). The red color is caused mainly by the presence of the element chromium. Its name comes from the Latin word "ruber" which is Latin for red. Other varieties of gem-quality corundum are called sapphires. Ruby is considered one of the four precious stones, together with sapphire, emerald and diamond.

Prices of rubies are primarily determined by color. The brightest and most valuable "red" called blood-red or "pigeon blood", commands a large premium over other rubies of similar quality. After color follows clarity: similar to diamonds, a clear stone will command a premium, but a ruby without any needle-like rutile inclusions may indicate that the stone has been treated. Cut and carat (weight) are also an important factor in determining the price. The world's most expensive ruby is the Sunrise Ruby. Rubies have a hardness of 9.0 on the Mohs scale of mineral hardness. Among the natural gems only moissanite and diamond are harder, with diamond having a Mohs hardness of 10.0 and moissanite falling somewhere in between corundum (ruby) and diamond in hardness.


All natural rubies have imperfections in them, including color impurities and inclusions of rutile needles known as "silk". Gemologists use these needle inclusions found in natural rubies to distinguish them from synthetics, simulants, or substitutes. Usually the rough stone is heated before cutting. Almost all rubies today are treated in some form, with heat treatment being the most common practice. However, rubies that are completely untreated but still of excellent quality command a large premium.

Some rubies show a three-point or sixpoint asterism or "star". These rubies are cut into cabochons to display the effect properly. Asterisms are best visible with a single-light source and move across the stone as the light moves or the stone is rotated. Such effects occur when light is reflected off the "silk" (the structurally oriented rutile needle inclusions) in a certain way.

#### Gun Deaths in America by the Numbers

he horrific slaughter of nineteen chil dren and two teachers in Uvalde, has once again focused the attention of the nation on the toll taken on American lives by guns. As with most highly charged emotional issues, and particularly ones that fall on the partisan divide, I find there is little objective analysis of the actual data and even less perspective on what the data implies.

There are many who object to a statistical analysis of such events as being cold-hearted and that doing so minimizes the tragedy of the loss of even a single life. While I appreciate that sentiment, I respectfully disagree. To the contrary, the more consequential, or in this case the more horrific, the problem, the more urgently we need to call on our full intellectual capabilities to fashion solutions. So, after Uvalde I began to dig into the data on deaths caused by firearms and found quite a bit that surprised me.

Prior to 2015, the number of deaths from a firearm on an annual basis had moved in a fairly narrow range, averaging about 34,000, which was about 10-11 firearm deaths per 100,000 Americans or slightly over 1% of all U.S. fatalities. However, since 2015 firearm deaths have been consistently moving higher each year and then took a sharp upturn in 2020, reaching an all-time high of 45,222. Preliminary data for 2021 indicates that number was perhaps slightly lower than 2020. The rate per 100,000 Americans has moved up to 13.7.

Most gun deaths in the U.S. are either suicides  $(\sim 54\%)$  or homicides  $(\sim 43\%)$ . The remaining  $\sim 3\%$ are due to accidents, police shootings or undetermined causes. Both suicides and homicides committed with a gun have been increasing over the last two decades, but most of the significant increase in gun deaths over the last two years has been due to an increase in homicides.

The significant increase in homicides coincides with an explosion in the number of gun sales in the U.S. The home security research group, HomeSafe.org, estimates that gun sales soared by over 150% in 2020 and 2021.

However, a series of Gallup surveys found that the percentage of U.S. households that own a gun has been slightly declining since 1972. This perhaps suggests that the increase in gun sales is more attributable to existing gun owners adding to their inventory, as opposed to a large number of new gun owners.

There is no question that the U.S. is an outlier when it comes to private gun ownership compared to other countries. The Small Arms Survey, an independent Swiss research group, estimated in its 2018 report that Americans, while making up only about 3% of the world's population, owns nearly half of the world's roughly 850 million privately owned guns. Their survey estimated that there were about 120 guns for every 100 Americans. That rate dwarfs all other countries. India came in second with just over 50. Canada was 34. The global average outside of the U.S. is about 7.

Next time, I will explore the issue of suicides and whether this ready access to guns has an effect on the incidence of suicide in our country.



# STATE CAPITAL HIGHLIGHTS **By Gary Borders**

## TEA Releases STAAR results for grades 3 through 8

The Texas Education Agency has released the 2022 State of Texas Assessments of Academic Readiness

Results for grades 3-8, which showed across-the-board improvements in all grades and subjects, with especially significant gains in reading.

"The investments that the state is making in reading academies and accelerated instruction are clearly paying dividends for our students, and the results are a testament to the hard work of teachers across our state," Texas Education Commissioner Mike Morath said. "While we still have much work to do to recover from COVID-related learning loss in mathematics, the improvements our students have made in reading are clear."

The spring results include exams in mathematics and reading for grades 3-8, 5th and 8th grade science, and 8th grade social studies.

#### MILITARY BASES HAVE BIG IMPACT ON STATE'S ECONOMY

A study analyzing the impact on the state's economy from U.S. military installations concludes they contributed at least \$114.1 billion to the Texas economy last year and supported more than 600,000 jobs across the state. Texas is home to 15 military installations and the U.S. Army Futures Command, which is located in Austin and runs modernization projects for the U.S. Army.

The study was completed by the comptroller's office at the behest of the Texas Military Preparedness Commission.

"It is amazing to see the tremendous economic impact these military installations have in Texas," said Texas Comptroller Glenn Hegar. "The importance of these bases reaches far beyond direct jobs and personal income. The facilities, and the men and women who work and are stationed at them, form the backbone of communities and support countless businesses and induced jobs throughout the state."

FORMER NFL PLAYER INDICTED FOR BOGUS MEDICAL CLAIMS

Former NFL player Narond



"Roc" Alexander was indicted recently for submitting fraudulent health reimbursement claims totaling more than \$25,000 to a health program for former NFL players. The case was brought by Texas Department

Insurance investigators along with the Bexar County District Attorney's office.

Alexander allegedly filed the bogus claims between 2014 and 2018 under the Gene Upshaw NFL Player Health Reimbursement Plan, which helps pay certain medical care expenses for former NFL players. He could face up to 10 years in prison

and a \$10,000 fine if convicted. "Insurance fraud hurts the people who actually need these funds to cover their health care costs, like the NFL players who benefit from this particular fund," Bexar County District Attorney Joe Gonzales said. "This indictment allows us to seek justice on behalf of the NFL players with legitimate claims who rely on these funds."

After playing for the University of Washington, Alexander signed with the Denver Broncos in 2004 and later played for the Houston Texans.

#### **GRANT PROGRAM TO BENEFIT** TRAVEL INDUSTRY

The travel industry, hard hit by the COVID-19 pandemic, is set to receive \$180 million of funds under a grant program funded by the federal American Rescue Plan Act of 2021. The program is designed to provide grants for the recovery of Texas businesses in the tourism, travel, and hospitality industry affected by the pan-

"Travel and tourism are critical components to both the state and local economies," said Gov. Greg Abbott. "Visitor spending at Texas destinations brings new money into communities and spurs local job creation across industries in every region of the state."

Anyone who has driven the state's major highways recently likely has noticed the number of 18-wheelers on the road has risen as businesses and industries work to fill demand in many sectors. The Texas Department of Transportation is reminding motorists to take extra care when driving around big trucks.

Drivers are especially at risk in the state's energy sectors, according to TxDOT. Last year, more than 79,000 crashes occurred in the state's five major energy production areas, resulting in 1,119 deaths — a 20% increase over the previous

Among the safety tips offered by TxDOT are staying away from a truck's blind spot; not tailgating; when passing a truck, making sure you can see both of the truck's headlights before moving back into your lane; and never crossing behind a truck that is backing up, since the driver can't see you.

#### **COVID-19 CASES INCREASE AGAIN**

The number of new COVID-19 cases reported in Texas during the past week by the Coronavirus Resource Center at Johns Hopkins University rose again to 84,417, with 115 deaths recorded. Both numbers are up modestly compared to what was reported the previous week. However, lab-confirmed COVID-19 hospitalizations in the state continue to rise steadily, with 3,007 reported by the Department of State Health Services. That's up 22% from the previous week and more than double what was reported a month ago.

"He's not my pet!" my mother said, indignantly.



#### **UPDATE ON COVID SHOTS FOR CHILDREN**

#### Harris County Public Health Now Administering COVID-19 Vaccine for Children Under 5 Years Old

Vaccination for children 6 months to 4 years follows the recent approval by FDA, CDC, and DSHS

Houston – Harris County Public Health (HCPH) is now administering the COVID-19 vaccine to children 6 months to 4 years old. This follows the recent emergency use authorization given to both Pfizer and Moderna by the U.S. Food and Drug Administration (FDA), along with approval by the Centers for Disease Control and Prevention (CDC) and the Texas Department of State Health Services (DSHS).

HCPH encourages parents or guardians to first seek a COVID-19 vaccine for their children from their primary care provider or pediatrician. HCPH will provide vaccines to children at its vaccination sites to residents who cannot obtain it otherwise.

All COVID-19 vaccines and boosters are safe and effective and have proven to provide strong protection against severe illness, hospitalizations, and death, including the latest version approved for children aged 6 months to 4 years old.

"Receiving the approval by the FDA and CDC to have children under 5 years vaccinated is another major step for us to reduce the spread of COVID-19 and hospitalization for everyone," said Ericka Brown, MD, MBA, FACHE, interim local health authority for HCPH. "We encourage all parents or guardians to contact their children's pediatrician or primary care provider and consider the options for a vaccine."

The Pfizer-BioNTech vaccine for children ages 6 months to 4 years old is a three-shot series, and each dose is one-tenth the dosage given to adults. Children would receive two doses three weeks apart, and a third dose at least two months later.

Moderna's vaccine approved for children from 6 months to 5 years is given in two shots (four weeks apart) and each dose is one-quarter the dose of that used in adults.

Vaccines provided by HCPH are free, and appointments are not required. To find a location near you, click here. Parents who wish to schedule an appointment online will be able to do so through ReadyHarris.org or vacstrac.hctx.net starting Monday, June 27.


