Channelview hears Public Safety plans

CHANNELVIEW — Harris County Precinct 2 hosted a meeting with the public last Thursday evening, Sept. 1 at the Bill Neal Center in Channelview. Public concern about crime in the community has been running strong, and this forum was meant to hear complaints, and also to present information on intitiatives underway by authorities to counter the criminal activity.

Subjects that were covered by the presenters included Stray Dogs, a new service phone number, 3-1-1 to request county services, crime rates as seen in data captures in the Channelview area, random gunfire, ShotSpotter to find shooters, VIPER to arrest violent criminals, homeless persons, nuisance properties, workforce jobs for homeless, or



Information on Public Safety initiatives were presented by Pct. 2 Commissioner Adrian Garcia, Channelview ISD Superintendent Tory Hill, and Harris County Sheriff's Captain Nathan Douglas. A crowd of about 60 interested persons met with the presenters at the Channelview Bill Neal Center for about two hours last Thursday, Sept. 1st.

Employ2Empower, and health concerns in the East side of Harris County.

Garcia explained that Public Safety was his #1 priority, but that he plans on aN holistic approach, that includes "Cops, Courts, and Community."

Garcia's community-focused approach to solving the underlying causes of crime includes investing in programs that address youth, food insecurity and hunger, affordable housing, behavioral health, and job training.

He also has acted to increase funding for a new full-time district court judge, 6 associate judges, visiting judges, and jury operations expansion.

GPISD stadium - Friday, September 9, 2022 -It was a classic Texas Friday Night Football contest. The Galena Park (GP) ISD North Shore Mustangs hosted the Spring ISD Spring Westfield Mustangs (SWM) in a battle of the unbeaten. With both teams ranked high in the state each brought their Mustang Nation fans and filled the stadium to capacity leaving standing room only viewing.

GPISD's Superintendant Dr. John Moore said when it was decided to close the gates because of reaching the safe capacity limits people still tried to get inside through other entrances. He said some fans even went and got on the sidelines without authorized field passes, so

GP YELLOWJACKETS REMAIN UNDEFEATED

Splendora, TX. September 9, 2022 - The visiting Galena Park Yellowjackets defeated Splendora Wildcats 28 – 14. The Jackets boast a 3-0 record and have shown much improvement under Head Coach Spiro Amarantos and his coaching staff.

This year GP team is well rounded on both offense and defense. The Eastside Gold Blood team has a strong running attack and against the Wildcats the Jackets quarterback Daniel Gomez showed he can pass.

Daniel Gomez, GP's sophomore quarterback threw a perfect 71 yard TD strike to wide receiver Jonathan Renteria for a touchdown (TD). Francisco Martinez had a good night making several big runs including a 20 yard rushing TD. Jordan Balderas

also had a good running game making long runs. The trio of runners with quarterback Gomez and running backs Balderas and Martinez should provide a good enough ground game to open up more pass completions.

Coach Amarantos's offense garnered 360 total yards, 289 on the ground and 71 yards passing. The rock solid defense is getting tougher each game and the team should be a strong contender for the district title.

The Yellowjackets now own a 3-0 record. Next week they have a bye and then they travel to Texas City for a 5A-2 Region III District 9 contest on Friday, September 23. Galena Park will play a Stingarees squad coming off a 7-0 non-league loss to Ball (Galveston, TX). The Stingarees record now stands at 1-1.

Chevron plans to update Pasadena plant

Jacinto City, Texas ~ September 1, 2022 ~ Chevron hosted the September Galena Park and Jacinto City Community-Industry Partnership (CIP) meeting at Jacinto City's Town Center. Tim Southerland Chevron's Pasadena General Manager (GM) presented their renovation project. It will upgrade the century old former Crown Central Refinery ** (PRSI) plant south of the Washburn Tunnel.

The renovation project is important to the North Channel communities in terms of employment, economy and the quality of the environment.

Sutherland with 31 years of experience began his Pasadena GM role in May 2019, charged with

the responsibility for safe and reliable operations of the facility. He joined Chevron in 1991 and was a member of the purchase team and served as the integration — transition manager for the purchase.

Chevron acquired the **Pasadena Refining System Inc. (PRSI) in May 2019 in order to process light-tight-crude-oil (LTO). The refinery will create ever-cleaner energy products that fuel local and global progress. Their global processes make fuels and lubricants under Chevron, Texaco and Caltex brands.

Light tight oil (LTO) – also called tight oil or shale oil is a low-density crude oil found within certain geological formations, such as shale or tight sand-

stone. By refining light crude it's expected to improve environmental permitted emissions in a safer way than other types of crude oil.

Southerland has said, "In all our work we place the highest priority on operating safely, reliably and responsibly to protect people and the environment. We're committed to creat-

ing social and economic value wherever we do business and will work hard to earn your trust, respect and be a good neighbor."

In 2021 to present they report a 75% reduction in air emissions and reporting issues. Over the past 12 recent months they had one excess opacity notification and zero other reportable "quantity" air

emission events. There were no major negative findings with multiple agency inspections in waste, discharge elimination, leak detection and spill prevention.

Sutherland reported improvements were made in their flare system performance. A refinery flare is a means to emit and safely burn gases or liquids into the environment which cannot be used otherwise. Or if storage reaches capacity limits or pressures increase near unsafe levels. If this happens a safety feature will trigger automatic pressure relief valves sending the excesses to the flare stack for disposal. When designed and used properly the flare emissions are harmless producing environmentally safe steam

and carbon dioxide (CO2).

The refinery will continue to produce a variety of petroleum products throughout nearly the project's entire construction period. By reconfiguring the plant and idling a few historically unreliable units, it will increase refining capacity and give more flexibility to adjust ingredients to manufacture products higher in demand. The reconfiguration also gives it the ability to make jet fuel and other new products. An increase in the plant's processing could result in producing 125,000 barrels of refined product per day.

The schedule of the new LTO project in 2022 to 2023 is to complete final



design engineering, build foundations and install new equipment, which are underway.

In 2023 to 2024 process pipe fabrication begins followed by connecting pipes to the LTO equipment. Testing and completion of the system is projected in 2024.

Lon Squires, Jacinto City's City Manager expressed his concern about the reliability and safety of the plant's old equipment. Southerland stated all equipment will be tested at half of their total life expectancy to ensure

Tom Ehlers, Galena Park's Fire Chief explained the state-of-the-art multiple siren warning system coming to GP from his grant application. He said as the project develops they'll be making residents aware of how and when it's going to be used.

Jerelyn Hughes-Glenn, representing San Jacinto College, IT Dept. reported their educational and technical training classes which could lead to employment opportunities at the Chevron facility. For more information call 281-542-2020 or CPD-IT@sjcd.edu.

has voted to increase Sheriff funding, Constable funding, an increase in salaries, a Viper Warrants taskforce, and over 400 new vehicles.

To aid the Courts, Garcia has voted for a 15% increase in funding for the District Attorney. This has been used for a new Environmental Crimes Unit, new prosecutors, and salary increases.

To aid the Community, Garcia has voted for additional funds for mental health and public health initiatives, violence deterence programs, Holistic Assistance Response Teams (instead of Deputies attempting to deal with domestic problems), nuisance abatement to clear 1100+ properties, and pre-emptive youth programs.

Garcia said that over \$30 million had been invested in parks, trails, community centers, public wifi, sidewalks, and solarpowered lighting.

Because of great public concern for packs of stray dogs roaming streets at night, HCSO Deputy Charles made a presentation on what the county is doing to deter this problem, and hos the public can assist. He said the HCSO Sheriff's office also deals with coyotes, feral hogs, and opossums. There is a number you can call for assistance with dangerous or stray dogs, 281-999-3191. He emphasized that responsible pet owners, who microchip and spay or neuter their animals, and keep them leashed, can hellp the problem a great deal.

Garcia said that the county now has a servie number, 3-1-1 which answers calls for all county services. This is similar to the service that the city has had for some time. Rina Fava of the County Universal Services Department made a presentatio-

in of all the benefits available to county residents by calling this number.

Channelview superintendent Dr. Tory Hill made a brief talk about the measures the district has taken to ensure safety for the students, He mentioned programs and training required by the state, which CVISD is following. He also revealed that the district has installed two license plate readers on Sheldon Road, to keep track of persons who might be a threat. This comment raised some concern and objections from the audi-

HCSO Patrol Captain Nathan Douglas presented a summary of deputy's activities in the Channelview area, and cited statistics that he said indicated a relatively low violent crime rate compared with other areas around the county. Public comments from the audience indicated that they desired more deputies patrolling the area, removal of homeless from the underpasses, and concern about random cunfire at night in some communities, including Channel-

wood.
Garcia indicated that these officers and their departments have had their budgets increased this year. In addition, he said technology such as ShotSpotter was a "force magnifier" reducing crime with fewer personnel.

He also praised the new VIPER program, that is intended to remove viiolent criminal who are out on bond. Working with the U.S. Marshal's service, and local constables, he said the task force is charged with making felony warrant arrests. Combined with increases in judges, court capacity, and district attorney prosecutors, the affect is anticipated in a serious reduction in crime, especially with repeat offenders.

The bracelet Evert was wearing during the match was a line bracelet set with diamonds made by noted jewelry designer George Bedewi. Traditionally featuring <u>diamonds</u>, this style of bracelet can also be set with colored stones or a combination of diamonds and colored stones. Thanks to Evert's incident that brought it into the national spotlight, sales of the bracelet exploded and became forever known as the tennis bracelet.

Considering Evert's famous mishap, you might be wondering if wearing a tennis bracelet during a match is a good idea. GIA experts offer a few suggestions so you can wear your bracelet without fear:

- 1. In addition to the clasp, add a safety catch on the side of the bracelet for added protection.



County Tax Revenues were up by 7% Last Year; here's what you can do about it

he Harris County Auditor's Office recently released its monthly report for February 2022, which is the County's fiscal year end. There is a lot to unpack in the report. But the number that jumped out at me was the increase in property tax receipts. From FY2021 to FY2022 property tax receipts jumped to over 7%. During that same time period, inflation for the Houston region was 1% and the County's population was virtually unchanged. Yet the County collected over \$113 million more from its residents than the year before.

You may recall that in September 2019, County Judge Lina Hidalgo and Commissioners Adrian Garcia and Rodney Ellis voted to raise property taxes by 8%. This is a link to the video of that meeting where the discussion and vote took place. The discussion about raising property taxes begins at 26:19 of "Item I, Part 1 of 2." The actual votes are taken beginning at 1:31:00 or you can see just the vote in this clip posted by my friend Charles Blain.

However, in a second required vote, Commissioners Radack and Cagle boycotted the meeting, blocking the increase. In reaction, Judge Hidalgo said, "Unfortunately, today commissioners Cagle and Radack chose to hide rather than face the tough reality of the impact that extreme revenue caps will have on our county," and "called the failure to increase taxes by 8% "dangerous."

Well, those "extreme revenue caps" allowed the County to collect new revenue at seven times the rate of inflation at a time that the County's population barely increased. Had the tax increase proposed by Hidalgo, Ellis and Garcia passed, the County would have collected almost 20% or roughly \$350 million more from Harris County taxpayers last year. Even more significantly, it would have established a base from which the Court would have been able to continue to raise taxes even higher indefinitely into the

I would encourage to look at your tax bill last year and calculate what an additional 13% in County taxes would have cost you. And then think about paying that additional amount each year in the future.

There are three positions on the Commissioners Court which are up for election this November: the County Judge and Commissioner Precincts 2 and 4. I plan to ask each of the candidates for these three positions to take a pledge that they will not vote to increase the property tax rate during their term. Any of them who refuse to do so will not get my vote.

"Well, that day we had a party that was partial to popcorn. Loved the stuff. I put two big cans on each mule in bag loads. One on each side.



TxDOT announces \$85 Billion Transportation plan

The Texas Department of Transportation has adopted a 10-year statewide roadway construction plan with a record \$85 billion price tag, officials announced last week. The Unified Transportation Plan authorizes the distribution of construction money that is expected to be available during the next decade. Within that framework, TxDOT works with elected officials and local planning organizations, as well as the public, to pick and fund the state's highest priority transportation projects.

In addition to highways the UTP addresses public transportation, aviation, rail, maritime, and freight and international trade. Many projects in the plan are highways identified on the state's 100 most congested roadways list.

"The UTP reflects a continued focus on improving transportation safety as the top priority, maintaining our current system, addressing traffic congestion, and improving statewide connectivity over the next decade," said TxDOT Commission Chairman J. Bruce Bugg, Jr.

Funding for UTP comes from "legislative and voterapproved initiatives that allocate portions of oil and gas taxes, sales taxes, and other money to the state highway fund," according to the TxDOT news release.

RRC APPROVES FINAL RULE FOR GAS PLANT WEATHERIZATION

More than 18 months after Winter Storm Uri shut down much of the state's electric grid, the Texas Railroad Commission last week adopted the state's first weatherization rules requiring natural gas facilities to protect gas flow to power plants.

"These new rules ensure our state's natural gas supply chain is prepared for extreme heat and freezing cold," said RRC Chairman Wayne Christian. "These rules will ensure that the natural gas facilities Texans rely on for reliable energy



are operational when we need it most."

Fines for administrative violations could reach up to \$1 million.

GAR HARVEST DRAWING NOW UNDERWAY

Anglers itching for a chance to catch a large alligator gar can sign up through Sept. 30 to enter a drawing through Texas Parks & Wildlife to legally do so on a stretch of the Trinity River that goes from Dallas through East Texas. A total of 150 anglers will have the chance to use any legal means to take one of these prehistoric-looking creatures that is over 48 inches in length.

The following counties are included: Anderson, Chambers, Dallas, Ellis, Freestone, Henderson, Houston, Kaufman, Leon, Liberty, Madison, Navarro, Polk, San Jacinto, Trinity, and Walker.

"This segment of the Trinity River has become one of the most popular destinations in the world to catch a large alligator gar, but concerns have been raised about the potential for overharvest and its risks to fishing quality," said Craig Bonds of TPWD. "With this drawing system, we are able to give 150 anglers the opportunity to harvest the fish of a lifetime while also meeting our management goal to conserve this unique resource for current and future generations of anglers."

TEXAS SEES FIRST MONKEYPOX FATALITY

State officials last week confirmed the first death of a Texas patient diagnosed with monkeypox. As reported by the Austin American-Statesman, the adult in the Houston area was "severely immunocompromised." The rare disease is gen-

erally transmitted by skinto-skin contact with someone already infected. Its symptoms are generally less severe but can be extremely painful, with rashes and blisters arising. Fever, headaches, rashes and blisters can also occur.

The Texas Department of State Health Services has reported a total of 1,695 cases in Texas to date.

GRIM YEAR FOR TEXAS COTTON GROWERS

Cotton production has been largely wiped out this year by drought and extreme heat, the Texas Tribune reported. The loss to farmers mainly in the Texas High Plains will be at least \$2 billion, according to the International Center for Agricultural Competitiveness at Texas Tech Univer-

Cotton isn't the only crop suffering from the heat and drought. Corn crops are in poor condition, and many pastures for cattle have been extraordinarily dry, forcing ranchers to sell their animals.

"They've had to liquidate their cattle herds due to the fact that there's nothing for the cattle to eat without supplemental feeding," Brant Wilbourn, associate director of commodity and regulatory activities at Texas Farm Bureau, told the

COVID-19 WORKERS' COMP CLAIMS UPDATED

More than 90,000 COV-ID-19 workers' compensation cases have been reported in Texas, along with 459 fatalities, according to the state Department of Workers' Compensation. Slightly more than half (51%) of the claims and 55%of the fatalities involved first responders and correctional officers.

Most of the benefits paid were for employer salary continuation or indemnity benefits in the cases of fatalities. The information was gathered through a conference call with 74 selected insurance carriers.

COVID-19 CASES, FATALITIES SHOW LITTLE CHANGE

The number of new cases of COVID-19 reported in the past week in Texas stayed steady at 56,734, with 183 deaths reported by the Coronavirus Resource Center at Johns Hopkins University. That is little changed from the previous

DSHS reported 2,598 lab-confirmed COVID-19 hospitalizations in the state as of Friday, also comparable to last week.

FOOTBALL SEASON WEEK 3: Aggies host Miami in meeting of ranked teams: Texans head to Denver to take on Wilson's Broncos

The No. 6-ranked Texas A&M Aggies host the No. 16ranked Miami Hurricanes on Saturday evening in a prime time game to be broadcast nationally on ESPN.

This will be a good test for Jimbo Fisher's team, which opened the season with a less than stellar 31-0 victory over Sam Houston State two weeks

Granted, the game was delayed some three hours due to inclement weather in the College Station area, and that could have had some effect on the lackluster performance of the Aggie offense. The Aggie defense, on the other hand, played well in pitching a shutout against the Bearcats.

That unit will get a real test on Saturday night when they face Miami QB Tyler Van Dyke, who threw for 193 yards and two TDs in the 'Canes 70-13 route of Bethune-Cookman.

The A&M-Miami game appears to be the marquee game this week in college football. In other offerings, No. 2-ranked Georgia opens SEC play at South Carolina, while Oklahoma visits Nebraska, and a game UTSA team head to Austin to take on Texas.

In the NFL, the Texans play their first road game of the season when they travel to Denver to take on Russell Wilson and the Broncos. Denver fans are hoping Wilson is the missing piece that returns Denver to the playoffs. The Dallas Cowboys hosts the defending AFC champs, Cincinnati, while Tampa Bay visit New Orleans.

Week 2 starts on Thursday night with a key AFC West tilt as the Los Angeles Chargers will visits the Kansas City Chiefs. Week 2 concludes with a doubleheader, with Tennessee visiting Buffalo in a meeting of defending division champions on ESPN at 6:15 p.m., while ABC will have Minnesota at Philadelphia at 7:30 p.m.



Running back Kenny McIntosh hauled in 9 passes for 117 yards, while the defense came up with two interceptions. This week they face a South Carolina team that has high hopes this year behind OU transfer QB Spencer Rattler (227 vards, 1 TD in the Gamecock's seasonopening win). Carolina 17 Oklahoma at Nebraska: Back in the day, this was one of the most anticipated games when these two met in the Big 8. The winner usually won the conference and headed to the Orange Bowl. My, how times have changed. While OU has been a consistent winner since these two teams were in the same conference, while Nebraska has struggled since its move to the Big 10. Cornhusker head coach Scott Frost's seat is blazing hot after losing the opener to Northwestern in Ireland. Nebraska did pick up a 38-17 win in Week 2. UTSA at Texas: Texas opened its season with a convincing 52-10 over Louisiana-Monroe as new starting QB Quinn Ewers passed for 225 yards and two TDs and found a new weapon in tight end Ja'Tavion Sanders, who caught six passes for 85 yards and one TD. Running back Bijan Robinson added 71 yards on the ground and a score. While the Horns were rolling, the Roadrunners put up a quality effort against Houston before falling 37-35 in triple overtime. UTSA QB Frank Harris proved he's a dual threat as he rushed for 63 yards and a touchdown and passed for 337 yards and three scores. Texas had better not look past the Roadrunners, because if they do, they might get embarrassed at home. This should be a competitive game, but look for Robinson's legs to make the difference in this one. My pick, Texas 33, UTSA 28

Miami at Texas A&M: If the Aggies are going to be serious about contending for a spot in the College Football Playoff (CFP), a win over a ranked Miami team could be a huge resume enhancer. A lot of experts believe Miami could be a very dangerous team this year led by Van Dyke at QB, who should play at the next level. The 'Canes are under the direction of first-year head coach Mario Cristobal, a no-nonsense head coach who returned to his alma mater after a stint at Oregon's head coach. Miami also has a strong running game led by Henry Parrish (108 yards, 3 TDs in season opener). A&M's run game was nonexistent in the season opener as star running back Devon Achane was held to just 41 yards. Quarterback Haynes King had a nice game passing for 364 yards and three TDs. Wide receiver Ainas Smith hauled in six passes for 164 yards and two touchdowns, while Yulkeith Brown grabbed two passes for 68 yards and a score. Fisher needs Achane to get untracked if his team is going to come away with the win on Saturday night at Kyle Field. Something tells me Achane will be the difference maker against Miami on Saturday. Kansas City: A good one to start Week 2 as the Chargers visit the Chiefs in an earlyseason AFC West showdown. The Chargers believe they have the pieces in place on both sides of the ball to wrestle the AFC West title away from the Chiefs and they can make an earlyseason statement with a win on the road Thursday evening. This game will feature two of the best young QBs in the NFL as LA's Justin Herbert (5,014 yards, 38 TDs) take on KC's Patrick Mahomes (4,839 yards, 37 TDs). The KC defense will have its hands full trying to corral Herbert, running back Austin Ekeler (911 rushing yards, 70 receptions, 647 yards, 20 total TDs in 2021) and wide receivers Keenan Allen (106 receptions, 1,138 yards, 6 TDs) and Mike Williams (76 receptions, 1,146 yards, 9 TDs). If the Chargers hope to pull off the upset, they must contain KC tight end Travis Kelce (92 receptions, 1,125 yards, 10 TDs). Kelce will continue to be Mahomes' go-to receiver now that Tyreek Hill is with the Dolphins. This should be a fun game to watch with plenty of offensive fireworks. The Chiefs are not going to give up their seat as the top dog in the AFC West without a fight, which the Chargers will discover come Thursday night. My pick, Kansas City 34, Los Angeles

Cincinnati at Dallas: After opening the season

against Tom Brady and Tampa Bay, the Cowboys face another tough test when they host the defending AFC champion Cincinnati Bengals on Sunday afternoon at AT&T Stadium. The Dallas defense will have its hands full trying to contain Cinci QB Joe Burrow (4,611 yards, 34 TDs), running back Joe Mixon (1,205 yards, 16 total TDs) and wide receiver Ja'Marr Chase (81 receptions, 1,455 yards, 13 TDS). Bronco fans are hyped about the prospects of Wilson returning Denver to the playoffs and he has some nice. young weapons to work with in second-year running back Javonte Williams (903 yards, 7 TDs) and wide receiver Courtland Sutton (58 receptions, 776 yards, 2 TDs). The Texans will need a big day from rookie running back Damien Pierce, the star of training camp, to take pressure off of QB Davis Mills (2,664 yards, 16 TDs). If the Texans hope to pull off the upset, Mills and WR Brandin Cooks (90 receptions, 1,037 yards, 6 TDs) will need to make plays in the passing game. This will be Wilson's first home game so look for him to have a big day against the Houston defense. My pick, Denver 34, Houston 20

Orleans: Tom Brady (5.316 yards, 43 TDs) and the Bucs play their second straight road game when they take on the Saints in an NFC South contest on Sunday. The Saints have won five straight against Brady and TB over the last two years and you know that does not sit well with the GOAT. Look for Brady to come out firing as he looks to make plays with wide receiver Mike Evans (74 receptions, 1,035 yards, 14 TDs), while running back Leonard Fournette (812 yards, 69 receptions, 454 yards, 10 total TDs) gets things done on the ground. The Saints will need a big day from running back Alvin Kamara (898 yards, 47 receptions, 439 yards, 9 total TDs), but it won't be enough as Brady brings an end to NO's dominance over his team. Tennessee at Buffalo: A good AFC matchup in the early Monday Night Football game pits the Titans against the Bills in Buffalo's home opener. Many are picking the Bills to win the AFC and the Super Bowl this year and taking down a quality AFC foe in Tennessee could do a lot for the Bills' confidence. Buffalo will be led by QB Josh Allen (4,407 yards, 36 TDs/ 763 rushing yards, 6 TDs) and big-play wide receiver Stefon Diggs (103 receptions, 1,225 yards, 10 TDs). If running back Devon Singletary improves and gives the Bills a lift on the ground, then the Bills could be downright unstoppable on offense this year. Look for the Titans to give the Bills a steady dose of running back Derrick Henry (937 yards, 10 TDs in just 10 games) to take pressure off of QB Ryan Tannehill (3,734 yards, 21 TDs)., who will be without his play-making WR now that A.J. County announces new crime reduction initiative

\$150 million for "Safe Harris" and VIPER

HARRIS COUNTY – County leaders on Wednesday touted an overall decrease in violent crime across the region and announced the Safe Harris initiative — a four year \$150 million public safety investment focused on further reducing crime in Harris County.

According to Harris County Judge Lina Hidalgo, the county saw a 7% decrease in violent crime since June 2021, with a 4% decrease in homicides. Additionally, Harris County Sheriff Ed Gonzalez added that since December 13, his department seized 279 guns, cleared 1,303 warrants, and filed over 1,000 charges — a majority of those being felony charges, Gonzalez said.

"We're moving in the right direction," Gonzalez said. "We're taking crime seriously here in Harris County, and we're going to continue to work collaboratively and learn

from what's working and what's not working."

The additional money will bolster the county's ongoing public safety investments and help fund the Violent Persons Task Force, or Viper, which will launch next month in Harris County with the aim to "take the most dangerous individuals off

the street," according to Precinct 2 Commissioner Adrian Garcia.

"These efforts are part

of the effort to address the common threat, which is in the rise of violence," Garcia said. "This is why more common sense gun laws and measures are needed."

The county also creat-

ed the Safe Harris website, which compiles already existing dashboards — including data on Harris County Jail's population and the county's criminal court backlog — into one centralized location, along with information about the county's public safe-

ty spending.

"SafeHarris.com is for you, our community, and is designed to give you a full view of the money and programs being developed and implemented," said Deputy County Administrator for Public Safety Perrye Turner.

During the briefing, the focus shifted to the county's short fiscal year \$1.3 billion budget, which focused heavily on public safety.

The Harris County Sheriff's Office saw a \$123.6 million increase in total funding from from 2019 to 2021, which funded additional overtime and increased salaries for county law enforcement,

according to the Safe Harris website.

Judge Hidalgo added that the budget for the Harris County DA's Office has increased by \$12.7 million from 2019 to 2021 and adamantly dismissed accusations of defunding law enforcement — claims that Hidalgo said were purposefully perpetuated by political opponents during an election year.

"We have increased the funding for every single law enforcement agency, so it is a lie," she said. "You are hurting our law enforcement and you are hurting our democracy when you're willing to spread lies."

Harris County Commissioners Court previously allocated millions to several programs aimed at reducing crime and increasing community safety, including a controversial "ShotSpotter" gunshot detection pilot program in Aldine and two public safety programs meant to decrease reliance on police intervention
